The applicant has addressed the issues relating to the access to the west of the site onto Staithes Lane by saying this will not be used for this application. The proposed access is now shown to the south of the site through the car park area. The Highway Authority's concern about this access is whether the applicant and the applicant's future customers have a right of access from the public highway on Whitegate Close to the land within the applicant's control.

Hi Ailsa.

The adjacent land to the east is Section 3 woodland and slopes steeply down to the beck. Care is needed during earth movements to ensure a buffer is maintained between machinery movements and storage of sediments and the edge of the site to prevent pollution of the beck and woodland flora. In addition, Himalayan balsam has been recorded close to the sites eastern edge, and care is needed to prevent potential translocation of seeds to other areas. No soils should be transported off-site, and a wheel washing facility at the entrance/exit to the site will help to limit potential spread.

Regarding the proposed landscaping, the proposals encompass an increase in the development size, and thus if approved a condition will be needed to ensure a detailed lighting scheme is submitted for approval before being brought into use so that the NPA can ensure no increase in light pollution or impact on foraging nocturnal species is caused. In addition, it is recommended that the proposed landscape planting is done with native species wherever possible (for example, coniferous hedging of holly, yew and juniper in addition to broadleaf trees/shrubs) in order to ensure no detrimental impact on biodiversity.
