# UNDERGROUND Installation Guidelines

### SITE PREPARATION

Thank you for choosing a supply from Flogas. These installation guidelines concern the most common tank size for domestic underground installations. (2000 litre).

There is a specific guidance note which provides greater detail on excavations which will be provided if you are arranging the civil works yourself. However, general guidelines are provided here.


The tank is secured to the concrete

base with four anchor points which need to be cast into the concrete, these points are required to be accurately placed in order to adequately restrain the tank. Two small 'shelves' are required within the pit for the installation of the sacrificial anodes which form part of the corrosion protection system employed on underground tanks. The installer of the tank will be required to enter the pit. An adequate means of preventing wall collapse must therefore be provided in order to comply with safety regulations. Should you require further information on this, please contact us.

The pit should be checked for safety and any sharp or protruding stones removed prior to the tank being positioned.

#### Siting

The tank must be sited a minimum of 3m (10') away from buildings, boundaries and combustible materials.



Normally around 20 to 21 cubic metres of earth is removed from the excavation which must be replaced by an inert material such as pea gravel (6mm to dust), stone dust or sieved sand (not beach sand).

The backfill material should be carefully laid during the backfill process with the final 100mm being finished with top soil. The tank area must not be covered with concrete, patio slabs or road surfacing material. No trees or deep rooting shrubs with large root systems should be planted in the vicinity of the tank.



If you are intending to carry out any building work in the area of an existing tank, excavation or gas supply, it is important that you notify us prior to doing so and we will be happy to provide free advice. If a variation is needed to the proposed tank location or pipe route, please contact us immediately to avoid any unnecessary inconvenience.

#### Installation

The trench must allow the pipe to be laid at a minimum depth of 450mm (18") deep from the

termination point on the outside wall of the house to the tank pit, as indicated on the plan provided by our Sales Representative.

#### Delivery of gas

The tankers which will deliver your LP Gas will, in most cases, not need to drive onto your property as they have a minimum of 30m (100') of hose. However, should the tanker need to drive onto your property please be aware it is 2.6m (8'6") wide, 8.23m (27') long and weighs up to 17tonnes.



The tanker which delivers is 2.6m (8'6") wide


