Although located just outside of the Scalby Conservation Area, the immediate area is of particular architectural and historic character as the three main dwellings of Ryefield, Brentwood and South Beck House (formerly known as Greenways) all derive from the same period of around the 1920's and are of the Arts and Crafts architectural style. Later developments of No's 111 and 113 Hackness Road relate to a later style of bungalow development.

DP4 states that proposals for development immediately adjacent to a Conservation Area should preserve or enhance the character and appearance or setting of the area.

DP3 seeks to maintain and enhance the distinctive character of the area by seeking a high standard of design detailing which reflects or complements that of the local vernacular.

It is acknowledged that the approved scheme did not fully reflect the Arts and Crafts architectural style; however it did reflect a more ancillary coach house style of development which was clearly subservient to the main house and therefore appropriate in this context.

Concern is therefore raised as the amended design of the new dwelling at Ryefield is to visually create an independent new dwelling, rather than recreating an ancillary form of development. As such, while I have no objections to this approach, the amended design is not considered to reflect the architectural character of the surrounding buildings, in particular that of Ryefield. The amended design as a result of its symmetrical and formal appearance, appears to recreate a Georgian style of architecture (with the exception of the bay windows) which is not considered to form a characteristic of the local vernacular.
