Morning Hilary – hope all is well with you.
Thank you for your email with regard to the external lighting proposals for Brickyard Cottage. I have taken the opportunity to discuss this will my client and there is some concern with regard to the safety of footfall users particularly at night and as the site is built into the hillside and therefore accessing the property (from some sides) is particularly steep.
With that, the client would be happy to omit one of the external lights. That being, to the right of the large sliding doors on the north elevation, since there is also a light nearby to the right of the door into the porch/utility.
Martyn and Natalie Hollingworth feel the second light suggested for removal on the eastern elevation of the timber extension is essential for safe passage around the building as it is the only light on that wall.
In addition to the physical safety, there is also a personal safety/use of lights for reassurance where the property is situated in a particularly isolated location. One of my clients often works away and can be away for long periods and therefore a need to be able to have external lights on if there is a need.
I hope that this provides a useful explanation to the lighting scheme and that it can now be progressed towards being discharged. Please don't hesitate to contact me if you require anything further.
