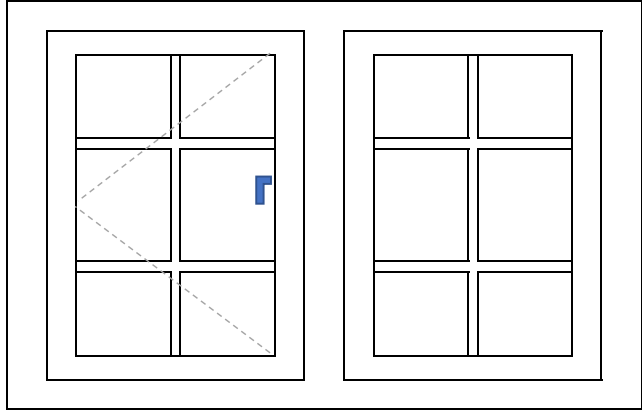

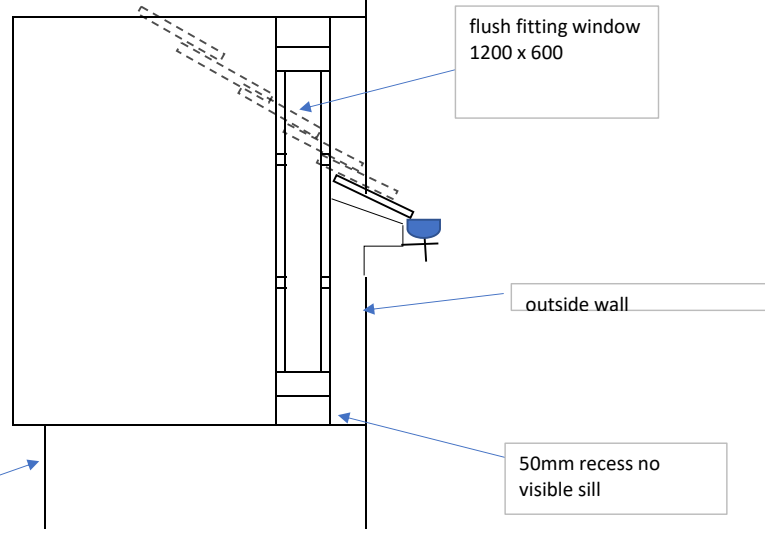

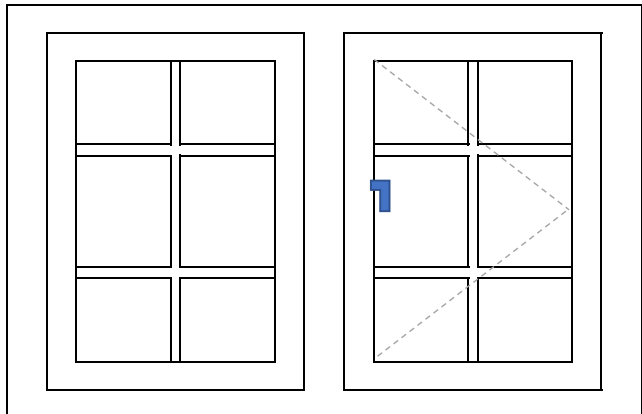
Bedroom 1 window (upper front left)



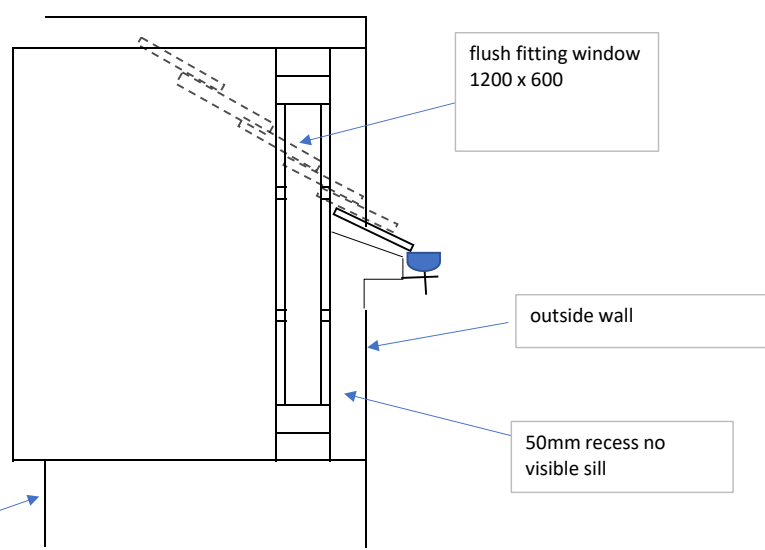
Bedroom 2 window cross sectional view



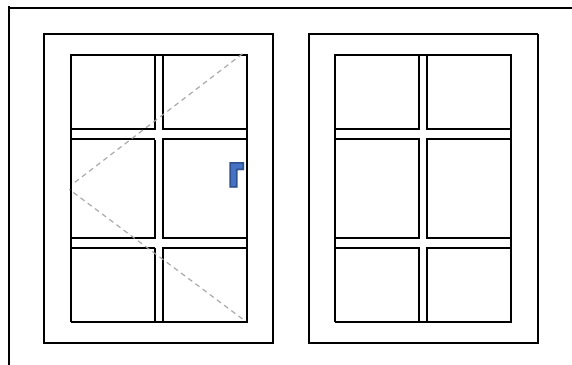
Bedroom 2 window (upper front right)



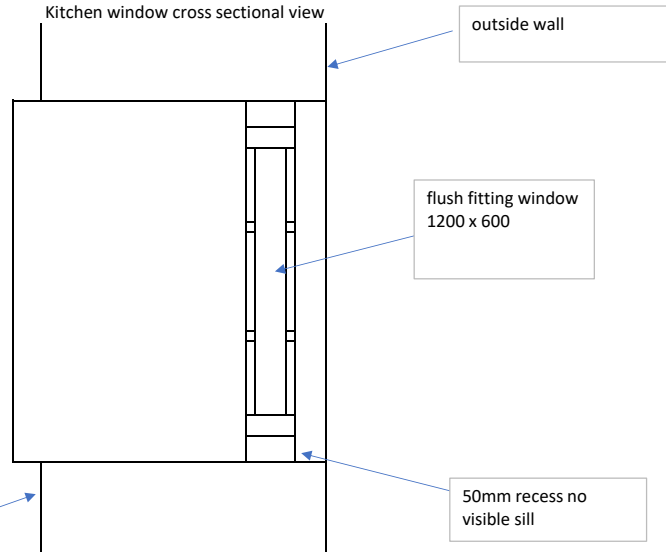
Bedroom 2 window cross sectional view

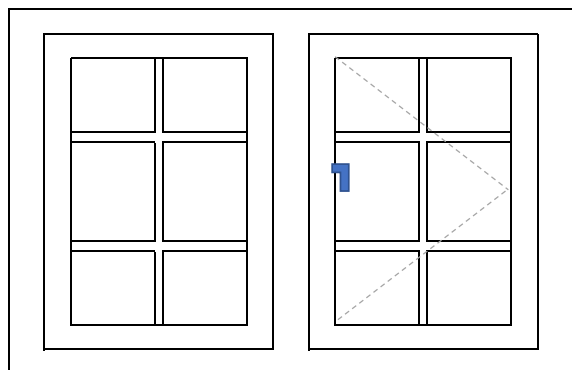


Kitchen window cross sectional view

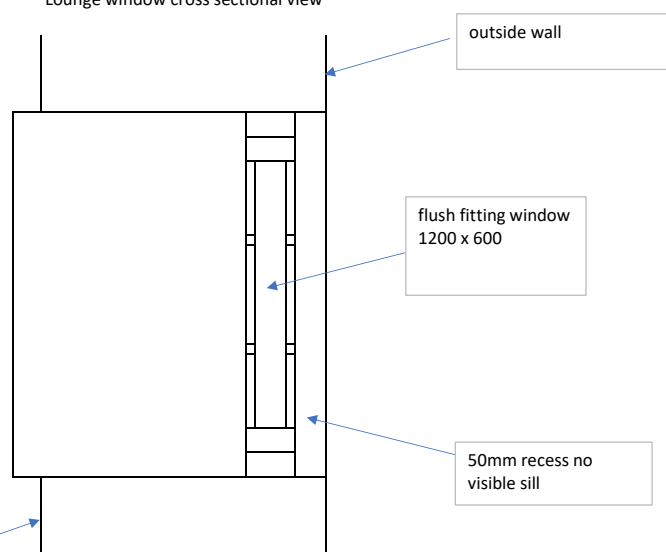


inner property wall
