Thank you for re-consulting Natural England on the above planning application. We would like to make the following comments:

Protected Landscape

The proposed development is for a site within a nationally designated landscape namely the North York Moors National Park. Natural England advises that the planning authority uses national and local policies, together with local landscape expertise and information to determine the proposal. The policy and statutory framework to guide your decision and the role of local advice are explained below.

We note that the track material has been amended from asphalt to stone, which is an improvement to the project. We advise that you seek clarification from your landscape team on the type of stone to be used to ensure that the stone type is appropriate with regards to the protected landscape, and in accordance with your authorities guidance document on agricultural tracks.

Your decision should be guided by paragraph 172 of the National Planning Policy Framework which gives the highest status of protection for the 'landscape and scenic beauty' of AONBs and National Parks. For major development proposals paragraph 172 sets out criteria to determine whether the development should exceptionally be permitted within the designated landscape. Alongside national policy you should also apply landscape policies set out in your development plan, or appropriate saved policies.

The statutory purposes of the National Park are to conserve and enhance the natural beauty, wildlife and cultural heritage of the park; and to promote opportunities for the understanding and enjoyment of the special qualities of the park by the public. You should assess the application carefully as to whether the proposed development would have a significant impact on or harm those statutory purposes. Relevant to this is the duty on public bodies to 'have regard' for those statutory purposes in carrying out their functions (section 11 A(2) of the National Parks and Access to the Countryside Act 1949 (as amended)). The Planning Practice Guidance confirms that this duty also applies to proposals outside the designated area but impacting on its natural beauty.

Dear Megan

The proposed new access track is adjacent to a relatively mature hedgerow for part of its length between NZ 78869 03848 and NZ 78841 03815. It is important that excavation works do not negatively impact on this hedgerow by encroaching too close to the base of the trees and their root systems. A minimum buffer of at least 1.5m from the base of the hedge should be observed.

There is a small possibility that wading birds may nest in the fields close to where the track is proposed. If the application is approved, a bird informative would be helpful to inform the applicants of their legal responsibility not to disturb nesting birds if they are encountered before or during the works.

In assessing the submitted proposals and reaching its recommendation the Local Highway Authority has taken into account the following matters:

The design standard used for the site is the North Yorkshire County Council Residential Highway Design Guide and the required visibility splay is 2.4 metres by 60 metres. The visibility available on the Autumn day of inspection was 2.4 metres by 40 metres.

Consequently the Local Highway Authority recommends that the following **Condition** is attached to any permission granted:

HC-10 VISIBILITY SPLAYS

There shall be no access or egress by any vehicles between the highway and the application site (except for the purposes of constructing the initial site access) until splays are provided giving clear visibility of 60 metres measured along both channel lines of the major road Smith's Lane from a point measured 2.4 metres down the centre line of the access road. The eye height will be 1.05metres and the object height shall be 1.05metres. Once created, these visibility areas shall be maintained clear of any obstruction and retained for their intended purpose at all times.
