Background

The Vicarage, Egton is a late 1960s detached two storey dwelling constructed of stone under a cement tile roof covering. The property is located at the southern end of the Egton Conservation Area and is adjacent to the Grade II listed St Hilda's Church. The Authority's Building Conservation Officer has recommended that given the number of non-traditional features on the property such as the shallow roof pitch, fascia boarding and central chimney, the Vicarage is considered to have a neutral impact on the character of the Conservation Area.

Planning permission was granted in October 2002 for the conversion of the existing garage into a study and the erection of an extension to form a new garage along with the erection of a replacement porch.

This application seeks to replace the existing concrete plain tiles on the original dwelling with Spanish slate tiles.

Main Issues

Development Policy 4 of the North York Moors National Park Local Development Framework states that proposals for development within or immediately adjacent to a Conservation Area will only be permitted where they preserve or enhance the character and appearance or setting of the area and where the design detailing and materials of the development respect the existing architectural and historic context with reference to the design detailing and materials of traditional buildings.

Development Policy 19 of the North York Moors National Park Local Development Framework states that proposals for development within the domestic curtilage of dwellings will need to take full account of the special qualities of the National Park's character areas and architectural character of settlements and will only be supported where among other things, the design of new development does not detract from the character and form of the original dwelling or its setting in the landscape.

The applicant has stated that the original dwelling's existing roof covering is significantly deteriorated and as such is in need of replacement. It is believed that the use of Spanish natural slate would be an improvement on the previous concrete plain tiles. Samples of two options for the proposed slate were submitted to the Authority for consideration. The Building Conservation Officer has stated that while they would favour a less shiny and slightly more textured style of slate, the first sample labelled R12 was the preferred of the two options provided.

The replacement of concrete tiles with the style of Spanish slate submitted to the Authority would not detract from the character and form of the original dwelling or its setting. Furthermore, the installation of the proposed slate is considered to have a neutral impact upon the character and appearance of the Conservation Area.

For the reasons outlined above, this application is recommended for approval.
