Dear Russell.
I have received the Building Conservation Officer's consultation on the proposed slate. The Officer has stated that whilst the slate is not of traditional proportions, as it is replacing modern concrete tiles they do not consider that it will harm the character of the Conservation Area. They therefore support the application.
In order to condition the use of the proposed slate I would be grateful if you could respond to this email with the details and specifications of the proposed slate, i.e. the make, style and dimensions of the slate. I would then be able to reference the email within my report.
The Building Conservation Officer has also stated that whilst not part of the application, they would advise painting the existing fascia boards black in order to further enhance the appearance of the property. The painting of the fascia boards would not require planning permission.
