Many thanks for meeting with me at 9 The Esplanade last week and for talking me through your proposal.

I have now received the Building Conservation Officer's comments on the above application and they have expressed their support for the proposals, which they feel will enhance the Listed Building.

The Building Conservation Officer has requested that further details of the proposed replacement staircase be provided prior to its installation. They have stated that a photo or drawing of the proposed staircase would provide the required information. Unfortunately the image included within the Design and Access Statement does not show the staircase in full and so does not provide an accurate representation of the proposed staircase design.

If you are able to provide the requested information prior to the application's decision due date (01 May) then I would be grateful to receive this at your earliest convenience. However, if you would be unable to provide the requested information at the present then this detail can be managed through a precommencement condition included within the Listed Building Consent which would read as follows:

No work shall commence on the installation of the new staircase until details of this feature to be installed in the new development have been submitted to and approved in writing by the Local Planning Authority. The work shall not be carried out otherwise than in accordance with the details so approved.

If you are happy for the above pre-commencement condition to be applied to the Listed Building Consent then I would be grateful if you could respond to this email with your confirmation. Otherwise, I will look forward to receiving the requested information at your earliest convenience.
