Hi Jill,

The proposed turning area and proposed widening of the yard would seem to conflict with the proposed scheme of hedge planting along the southwest of the application site as required under condition 16 of NYM/2018/0384/FL and discharged under NYM2018/0603/CVC. As the plan provided includes no indication of where this hedgerow is located in relation to the revised plans it would be helpful for the line to be clarified so mitigation/compensation obtained through the initial approval is not lost under this alteration of site access details.

I also note that some cutting back of the vegetation at the front of the site is mentioned, although not explicitly. A bird informative would be useful to set out the legal responsibility of the applicant to protect nesting birds.

#### **Note to the Planning Officer:**

In assessing the submitted proposals and reaching its recommendation the Local Highway Authority has taken into account the following matters:

The proposed turning area is outside the extents of the publicly maintainable highway. The only item of work included within the highway boundary is the moving of the Pole stay. This work should be carried out by the utility company.

The design standard for the site is Department for Transport and the required visibility splay is 2 metres by 160 metres. The achievable visibility, once some of the hedges are cut back will be in the region of 2 metres by 160 metres.

Consequently the Local Highway Authority recommends that the following **Conditions** are attached to any permission granted:

1. MHC-05 Visibility Splays at the existing access

There must be no access or egress by any vehicles between the highway and the application site until splays are provided giving clear visibility of 160 metres measured along both channel lines of the major road from a point measured 2 metres down the

centre line of the access road. In measuring the splays, the eye height must be 1.05 metres and the object height must be 1.05 metres. Once created, these visibility splays must be maintained clear of any obstruction and retained for their intended purpose at all times.

2. MHC-09B Provision of Approved Access, Turning and Parking Areas

No part of the development must be brought into use until the access, parking, manoeuvring and turning areas for all users have been constructed in accordance with the details approved in writing by the Local Planning Authority. Once created these areas must be maintained clear of any obstruction and retained for their intended purpose at all times.

#### Reason for Condition

To provide for appropriate on-site vehicle facilities in the interests of highway safety and the general amenity of the development.
