The Bay Tree, Station Road, Robin Hood's Bay: Response to Planning Officer's comments (application ref: NYM/2020/0087/FL & NYM/2020/0092/LB, date received: 30/3/2020).

Officer's comments marked in black. Studio Partington (SP) response in red.

# Proposed use

Further information is required regarding the intended use of the property. Whilst the description seems self-evident, the plans show a substantial amount of accommodation with little or no supporting information. For example, there are 7 no. en-suite bedrooms proposed. Are these to be rented on a short term basis to artists or will they be occupied on a longer term basis by staff or the manager of the facility? Will the facility be open to the general public to visit such as the café area or for performances or will it be restricted to pre-booked individuals/groups only?

You have also indicated on the application forms at section 22 that opening hours are relevant to the proposal yet have not specified any. Given the proposal will lie within a predominantly residential area it is important that the intended opening hours to the public for performances are specified along with times the recording studio and practice rooms can be used to minimise noise disturbance to neighbouring residents.

I note that the floor plans indicate two entrances to the recording studio with one leading to the reception which I presume would be the main public entrance and another from the north corner of the site leading directly into the live room. With the double doors proposed to this second entrance it implies this would be the main entrance for the loading of equipment yet this is closest to the neighbouring residential properties where there is no space for vehicles to load/unload. Please can you clarify?

Furthermore there is no supporting evidence as to the likely demand there will be in the locality for such a facility although you refer to use by choral groups and brass bands. I would assume there is a business plan for the proposal and it would be most useful to have sight of that so that the need can be assessed against what existing provision there may be in the locality. Much was made of the need and support locality for such a facility during our pre- application meetings so it is disappointing that no reference has been made to this I the submission.

# SP response:

The proposed seven en-suite bedroom accommodation will only be available for artists on a short-term basis for the duration of their studio rent. No provision is made for permanent accommodation for the members of staff or the manager.

The access is restricted only to pre-booked individuals, groups, local school parties and community groups, and will not be open to the general public to visit. The terrace and lounge areas similarly are only for the use of the studio engineers and the booked users.

The operating hours for access and any deliveries will be between 9am to 5pm, however, the facilities for the recording studio will be used on a 24/7 hour basis. By offering residential accommodation the studio will be able to offer bookings in large blocks of time for musicians to rehearse and record, for instance for professional use by media companies and record labels. The ability to offer a 'recording retreat' is fundamental to the commercial viability of the proposal. The residential nature of the facility will reduce movement to and from the studio.

Due to the highly soundproof space requirements, isolated from any external noises, the building envelope will be of a high acoustic performance that will not cause any noise disturbance to the neighbouring residents and the artists using the studio facilities.

There are two studio entrances proposed; one adjacent to the reception which operates as the main entrance for the studio users; and a secondary recessed double door entrance, not directly visible from Prospect Filed, restricted only for large equipment and musical instruments delivery. The position of this entrance allows a level access for infrequent delivery of larger instruments such as pianos.

Please note that the facility will not be open to the general public to visit and does not have a café.

### Noise

The Environmental Health Officer has commented that the submitted information neither describes the uses of the venue, the times of operation, nor provides any evidence of a noise impact assessment as previously requested at pre application stage and as such is minded to object on grounds of insufficient information. However she goes on to comment that with carefully considered construction methods and materials, design of ventilation and extraction systems, restriction on noise emission levels and timings, together with noise and dust control during the construction phase, she believes it may be possible to operate this venue with minimal impact on neighbouring residents. For reference the Environmental Health Officer's comments at pre-application stage are repeated below for you to consider and address accordingly:

My initial thoughts are about the potential to create noise and disturbance to neighbouring residents. I expect that the recording studio side of it will be properly acoustically insulated to achieve the best quality of sound, and provided the sleeping accommodation is tied to the users then their amenity is of less concern. British Standards for building construction relating to acoustic insulation, are essentially aimed at domestic to domestic transmission internally, and pay less attention to very loud noises internally being transmitted externally. I would expect great attention to be paid to external transmission, probably something like a 60dB reduction, depending on the volumes created internally, concentrating on prevention of low frequency elements. This will probably necessitate high specification fixed glazing with powered extract ventilation to noise generating rooms, which may have a consequence for external noise and visual impact.

I would expect an acoustic survey to be carried out to ascertain overall background (L90) levels, as well as problem frequencies, to determine possible impact at external amenity areas of nearby residents during daytime and evening, and night time at external facades. The exact scope of the acoustic survey should be discussed with myself before commencement. The survey should be chosen to represent a range of exposure periods taking into account the seasonal variation in visitors/traffic and the location of external amenity areas. This should be used to inform the project design, and specification of window, door and glazing elements.

Separately there will be an impact from traffic to the site from parking and 'people' noise from use of the external patio area, which I would expect not to be used beyond midnight, unless it is enclosed within a courtyard to prevent noise escape. Coupled to this is the impact of external lighting and the potential to cause glare and light spill and will need to be designed to minimise this impact.

# SP response:

The applicant recognises the need for proper consideration of the acoustic design- this is essential for the functioning of the studio as well as the impact on the neighbouring residential properties and the environmental officers comments on design are noted. Allowance has already been made in the design of the studio for isolated floor wall and roof constructions. It would be preferable for the background surveys and design criteria to be set by a planning condition, with post completion verification. Could the scope of any survey and resulting performance criteria be established with the planning officer?

Note: Due to the current isolation measures, any noise background surveys undertaken in the immediate future (3-4months) are unlikely to be representative, with irrelevant figures.

# **Design**

I would be grateful if you could supply a copy of the elevations including the streetscene elevations without the proposed tree planting shown as this is proving misleading. I would also be grateful if you could amend the street elevations with the eaves and ridge heights of the proposed development and the neighbouring properties annotated. A street scene elevation from the south showing the development in relation to The White Owl (with eaves and ridge heights annotated) is also requested. Comments have been made regarding the overall height of the proposed extension and whether there is a need for the first floor accommodation? Omission of this would enable the overall height of the structure to be reduced which would help limit the impact of the proposal on the host building and the surrounding residential properties.

# SP response:

Drawings will be amended to omit the trees and include White Owl's levels. Southern elevation with ridge heights.

We appreciate the concerns over the overall height, however, the proposed extension sits lower than the listed Bay Tree and substantially lower than the existing 80's extension. The building height is determined by the acoustic and volumetric requirements of the recording studio, which is calculated at seven meters and not by the artists' accommodation. As such, the omission of a floor will cause a volume loss that will limit the range of the recording sessions that can be accommodated in the studio.

# **Traffic**

You have indicated on the application forms at Section 13. that there is no off street car parking available at the property and that the proposal will result in a gain of 4 spaces, and the Highway Authority have based their initial comments on this assessment. However serving the former care home was a large gravelled area to the rear of the property which although not marked out did provide a reasonable number of parking spaces for residents and visitors; in fact our historic aerial photographs clearly show the area used for car parking. As such in reality the proposal will result in a loss of off-street car parking with a potential increase in traffic generated. As such further information is required regarding the likely traffic generated by the proposal so that a fuller assessment can be made in the impact on the surrounding area.

### SP response:


The recording studio is likely to be used out of peak hours when ample parking will be available in the Station Car Park near the application site. It is difficult to determine the number of the parking spaces of the informal gravelled area to the rear of the property. Therefore, the proposal seeks to formalise the available parking, offering four marked parking spaces on a similar location with the gravelled area, whilst creating a higher quality setting while approaching the studio entrance.





I refer to the planning application relating to the old care home at the Bay Tree in Robin Hood's Bay and its conversion into a recording studio.

I am a peripatetic music teacher and conductor working in schools mainly in Fylingthorpe and Whitby. At Fyling Hall School, I teach woodwind and organise and lead an orchestra club. I also lead a Saturday music centre at Whitby, as part of North Yorkshire County Council's county music service. I was excited to learn of the proposed redevelopment of the old Bay Tree care home to turn it into a state of the art recording studio as this would offer an important performance and education facility that we do not currently have.

I have read the planning application and documents which are publicly available and note that not only will the proposed recording studio be for professional musicians and artists, it will also be available to use by local school and amateur music and community groups and importantly have the necessary size and capacity for this.

This would be a fantastic opportunity for aspiring local musicians and give them a real taste of what being a professional musician is like.
