The submitted drawings appear inconsistent. For example elevation 1 shows 1 camera, whereas two are indicated in plan.

During a recent enquiry a number of unauthorised works were identified, the most relevant to this application are a number of security lights, and alarm boxes. Although these are small additions they remain unauthorised and as a whole can result in cumulative impact. Historic England Advises that cumulative impact of incremental small scale changes may have as great effect on the significance of a heritage asset as a larger scale change.

Further to this given that these cameras have infrared vision up to 30m. I do not see the need to have so many – so close.

Whilst I appreciate that that applicant has tried to place them close to down pipes to minimise their impact would be less if away from the principal dwelling as much as possible. I raise no objection to the one proposed for the timber building. But I raise concerns about the number proposed to the principal building, especially when multiple cameras are proposed for a single elevation.

Following correspondence with the agent the Building Conservation department were under the impression that an application to regularise and remove some of the unauthorised developments at the site would likely be forthcoming. Can the applicant please advise if this is still the case?
