I am writing to register my objection the proposed site location of the 15.97M satellite pole and its additional accessories at Scalby Nabs. The site in question is on land adjoining mine.

As the only contact with your office is a pre-recorded answer phone message I have had to rely on the kindness of a neighbour to send an e.mail on my behalf.

A couple of queries spring to mind. Is there any reason for the paper application displayed on the gate to be be undated ? How are we to know whether or not it has actually been there for 21 days before you remove it ?  
Lock - down has it`s advantages for some !

The owner of the field (and presumably the financial beneficiary) has the land higher than the prospective site and less obtrusive. Andy Wilson, the C.E.O. at the Park in the "Moors Messenger" is always stressing how considered and important the views of Park residents are but of course we are lacking in numbers and any complaints we make are almost always over ridden. Presumably this is another case of "going through the motions" on what is I suspect a "fait accompli"
