'The proposed development is unlikely to have a detrimental impact on neighbouring amenity given the new brick structure would be built to the same dimensions as the existing timber shed. Whilst the proposed shed would have the appearance of a more 'permanent structure', it would not be out of character with the surrounding properties, mimicking the style of other outbuildings in the vicinity, and would not have an unacceptable impact on the street scene'
