Dear Tom

Thank you for your reply. As the conditions will not be fully complied with by 6 June 2020 I have sought the advice of the Authority's solicitor regarding an extension to the timescale for compliance.

Normally you would need to formally apply to vary the contents of a planning condition. In this case you are not proposing to vary the works required by condition nos. 1 or 2 only the timescale given the recent and ongoing lock-down imposed by the Government in an attempt to limit the spread of the Coronavirus. These are considered to be exceptional circumstances and as such it would be unreasonable for the Authority to enforce compliance with those conditions. However as the Government begins to ease lock-down and many are being encouraged back to work, we consider a 2 month extension to the timescale set out in those conditions to be a reasonable period for you to employ a painter/decorator to finish the work.

With regard to the colour of the external doors, we would suggest a muted Heritage colour to complement the cedar cladding rather than a primary colour but will be no more prescriptive than that.

Dear Tom,

As I am sure you will be aware the conditions attached to your most recent planning permission for the variations to the design of the supported living accommodation required certain remedial works to be undertaken within six months of the date of the decision. As the planning permission is dated 6 December 2019, the works should be completed by 6 June 2020.

I have attached a copy of the planning permission for ease of reference. As you will see condition 1 requires the removal of the timber lintels to unit 1 and the store along with the painting black of the fascia boards and the concrete lintels to unit 1 and the store. Condition 2 requires the external doors to units 1 and 2 to be painted a colour to be first agreed in writing within the Local Planning Authority. From our records I am not aware we have agreed the paint colour for the external doors.

I would be most grateful to hear from you as to whether the remedial works have been undertaken and if so, photographs would be appreciated. If the works have not yet been carried out please can you advise when you expect these to take place.
