#### Hi Megan

The provided survey, carried out by MAB and dated September 2020 is appropriate for the purpose and gives us sufficient information to determine this application. The barn to be converted was assessed as of low potential for bat roosts and a single activity survey carried out at an optimum time of year found no evidence of bat emergence. On this basis, no further survey work is required and a bat licence will not be needed. Planning permission may be given.

Section 9 of the Bat, Breeding Bird and Barn Owl survey report dated September 2020 setting out mitigation and compensation actions to ensure no detrimental impact on protected species occurs should be conditioned

Details of any external lighting proposed should be reserved under condition to ensure no impact to foraging bats and other nocturnal fauna, as well as to support the dark sky qualities of the surrounding area.

#### Dear Megan

I have read through the MAB Ecology Breeding bird, bat and barn owl scoping survey report dated January 2020. It identifies that there is no evidence of current bat or bird use and the buildings are of an overall low suitability for bats. The survey does however make clear that it was not possible to rule out use of numerous crevasses and gaps by crevasse dwelling bats or small passerines and therefore further survey is required. One bat activity survey has been identified as necessary to determine whether there is any bat presence in the buildings, in accordance with Bat Conservation Trust guidance.

Despite the low likelihood of presence, there is still a possibility for a number of crevasse dwelling bats to be present in the site which is surrounding by excellent bat foraging habitat. It will therefore be necessary for a report of a bat activity survey to be submitted prior to determination of this application clarifying any bat presence within the buildings and setting out any mitigation as required. As we are currently within the appropriate window for bat activity surveys (May-September, but ideally May-August), it is not anticipated that this requirement will constitute an unreasonably delay. If ultimately approved, a condition restricting works to outside of the bird nesting season will be required, unless checked immediately prior to commencement by a qualified ecologist.
