Planning application NYM/2020/0275/FL

I would like to make the following comments in addition to those already submitted.

In communication with the highways department they have informed me that as the developers own land they are in a position to provide passing places. Over the busiest section, from the junction of the A1471 to the Bridlepath to Mulgrave farm just under half the land on either side of the raod is not in the ownership of the developers and contains what is perhaps one of the most difficult sections.

In assessing road usage the highways department tell me they cannot make use of anecdotal reports . With limited resources the department I would suggest cannot acurately assess the current road usage. They go on to tell me on the 11th of September during a site visit, they encountered 4 farm vehicles, but reported no dfficulties, however what is not clear is the duration of the visit, had they been visiting on the 23 rd of August then they would have encountered some 37 tractors and trailers on the road on a two and a half hour period, that equates to almost one every five minutes, Subsequently on a busy day I observed a vehicle having to reverse twice in the same position on that part of the road where the land is not in the ownership of the developer.

I informed the Highways department on the 31st of August that the entrance to the underground dyke, whose entrance is on my property , was collapsing and that there was evidence of the tunnel wall bulging near the the begining of the dyke. An officer of the department visited on the 15th of September who confirmed there was no immediate danger, he would report his findings to the area manager and that the department would keep an eye on the situation, in the meantime should the headstones collapse I was to inform them. Since the officers visit there has been further movement, should the planning application go ahead , then the use of heavy vehicles will inevitably cause the collapse of the headstones, if it has not already done so.

I have now viewed the new plans, whilst I am please to see that the Barn is being retained, I find the structure out of keeping in .this environment.

Between the 12th and 25th of July I noted 27 tractors on the road to go down the bridleway, in addition on 2 days there were tractors at intervals of approx 15 minute intervals accessing the unmadeup road to Ugthorpe. This together with my previous recording of traffic on the road is in prime holiday season, this road cannot cope with any more traffic as the structure of the road makes passing places in my view impossible in the right areas, users on foot, bike and horse will remain at risk.

The applicants have already made changes to the farms in the vicinity and the amount of traffic moving along this road is getting excessive

We now have farm contractors vehicles moving in and out, on top of the normal activities of the farms already present, we have pheasant breeders, motorcycles, on top of the normal coming and going of those already living in this road, one of which is a riding school. Young children are often on ponies along this lane. To allow this development will just increase traffic to a ridiculous level. I believe that these buildings should remain for agricultural use only. This must be one of very few farms in the Park whose outbuildings currently remain and as such should be preserved for prosperity.

To say they are redundant when a large and ugly polytunnel, which I assume is used for lambing, exists, is I believe disingenuous.

With the splitting of the tenancy at Mulgrave Farm there has been since the beginning of April a noticeable increase of mainly large agricultural vehicles on the road and bridleway.

This is a single track road with no passing places, although in part there are grass verges, these are extremely soft for most of the year and are a hazard for the uninitiated.

In addition the road is not treated in winter and there are a number of places where water builds up causing ice sheets.

From my experience of living in a similar situation in North Wales, visitors as a general rule had difficulty in reversing for prolonged stretches, causing frustration and delay.

It is my strongly held view that this road cannot and should not be expected to be open to more traffic, one must remember that in addition to the vehicles of the occupants, there are also those of the service providers

We have concerns over the size of the potential plans which will bring a significant increase of traffic down the single track lane.

This lane is very narrow in parts together with a dangerous turn onto the A171 which often has had collisions with both vehicles turning down the lane and vehicles pulling out onto the main road. This lane has no passing places.

There is a riding stables established for many years, and horses and riders are frequently on the lane.

We live on Barry Bank Lane and are concerned that visitors to the development will use the lane as a short cut. The lane is mainly unsuitable for motor vehicles but already we have off road bikes hurtling down.

Another concern is regarding the environment, over use of farm buildings converted to holiday accommodation is already spoiling the once tranquil feel of our countryside in many areas. The development is in a rural, quiet setting it would be a shame to blight it with such a obviously over developed plan.

resulting in a 7 day holiday producing a possible 280 vehicle journeys a week

as well as increased farm traffic now that

Mulgrave estate as spilt up the farm land

and leasing it to different farms in the area, resulting in a lot of heavy farm machinery also using the road, making this road extremely busy and hazardous to my liveries and riding school clients.

As recently as Jan 2017 i was put off a planning proposal regarding my equestrian business due to a statement from yourselves that the highways authority would be against it due to the a171 having an accident record and that it was recommended that the scale of the development should be limited to current levels and if not possible then the development should be refused.

I felt I had to write again further to my email last week. I've read a document from the highways authority that has been sent to you and would take issue with some of the content. It mentions the numbers of cars per dwellings . There's no mention of the inordinate amount of farm vehicles up and down this road, now Mulgrave have altered the farms round there's a lot more traffic. Thers also traffic due to pheasant breeders. There's traffic coming and going to the riding school .It says the road is managed by the highways people, they cut a strip of grass on the verge once a year, not what you'd call well maintained

There is grass growing down the middle of the road. I've had my fence damaged in the winter by vehicles coming off the road. We never get salt on the roads as soon as it snows we're marooned unless we walk to the main road.

The main road is a nightmare, in the few years we've been here I've seen the road closed twice. The last time there was a fatality. It's a dangerous turning as coming from Whitby the turn is straight after the bend. Planning has been turned down before for other people, the

reason was because the road is not suitable for the extra traffic.

On top of all this there are a lot of farm vehicle using the Bridleway now, these vehicles are so big , any people or horses have to move off the track.

I would like to add to my earlier comments now that I have had sight of the report from the highways department, namely

Local Highway Authority Considerations and Recommendations

Having read this report I believe that to say that this road leads to 4 different farm house clusters does not accurately reflect the current situation.

There are 2 farms and one long established Riding School and Livery yard, excluding the 2 farm houses there are five other dwellings and a holiday cottage.

A shooting syndicate is based at Biggin House Farm where they breed their pheasants and gather on shooting days.

The riders from the livery yard regularly use the road to access the moor , biridleway and track to Ugthorpe, as do walkers and cyclists.

The tenancy arrangements at Mulgrave Farm have changed and from April 1st we have seen a greatly increased number of large tractors and trailers accessing both the bridle path and track from the road

On the 25th May 3 such tractors with silage tankers together with other tractors went up and down the road to access the bridleway every 10 -15 minutes between the hours of 9 and 6. On the 26th this was repeated, though between approx. 10 -5.

On other occasions since the 1st of April there have been large tractors and trailers carting silage and farmyard manure over a number of days .As silage making takes place approx. every 6 weeks. we can expect similar amounts of traffic in the following weeks.

I understand that a previous planning application was rejected by the highways authority on the grounds that the junction on the A171 for traffic turning right was dangerous, following a number of accidents. If this were in fact the case then serious questions must be asked about the current recommendation.
