Hi Kelsey,

I would like to request some more information about the above application for the installation of a sculpture and access path in Dalby Forest. I have no objection to the use of the historic environment feature as part of the installation, but it would be useful to have some photographs of the rabbit type (trap), and the banked feature in which it sits. I don't think archaeological mitigation is likely to be needed for the vegetation clearance or creation of the access path, but this will help us make sure. If any photos are available please let me know, otherwise perhaps we could organise a site visit?

I would also appreciate being consulted on the contents of any information panels to accompany the installation. The design statement notes the rabbit types as being Victorian, but HER records indicate a 17<sup>th</sup>/18<sup>th</sup>C origin. If the applicants would like any data from the HER or to discuss the archaeological background let me know also, we have some literature on this.

Dear Kelsey

I have no objection to this development, however I do note that the proposed path will cross a high priority species rich road verge either side of the forest drive. Turves should be cut from areas likely to be highly disturbed during the works and laid aside, vegetation uppermost, for replacing around the finished path. Turves removed from the line of the path itself should be used elsewhere on the site to border the new path and enable the species rich vegetation to extend away from the verge into the forest on either side. No vehicles or materials should be parked or deposited on the verge during works.
