# Ref; NYM/2020/0836/FL

Please find enclosed further illustrations for the location to our property within the proposed site area of the mast, cabinets, turning area, concrete base and service road.

I have endeavoured to illustrate the height difference of the surrounding fields in relation to our garden, plus the gradient from top to bottom of our property.

Pictures 1 - 4: show the proposed site of 20mtr. mast, cabinets, concrete base with turning circle, all are clearly visible from house and garden, in fact the rural aspect would now be replaced by a large abomination dwarfing a once picturesque outlook.

Pictures 5 & 6: are where the service road would join the mast site, road and concrete base would clearly be visible.

Picture 8: Top corner of garden looking at a 'so called cops that will hide the mast' according to the proposed plan submission.

Pictures 9 & 10: View of mast site from top of garden and reverse view down to East Farm, the land slopes down further increasing the aspect of height to the mast.

Pictures 11 & 12: These show views from left hand side of garden where the proposed service road would be situated.

Pictures13 & 14: Views from back bedroom & 2 bathrooms that would be dominated by the 20mtr. mast, cabinets, fence, concrete base and turning area.

Picture 15: Telephoto shot of views from 2 bathrooms which shows better definition and detail.

The proposed plan to erect a 20mtr. mast, cabinets, 300+ mtr, service road along a hedge line is impossible and would not work. The service road is too narrow to allow heavy site vehicles etc. to make 90 degree turns, they would need further space and more road adding to greater prominence to the road on the landscape. The service road would clearly be visible from the lane up the side of our house, through the hedgerow etc. and down through the bottom entrance gate.


I cannot believe that no consideration was given to the home owners of East Farm as we are clearly affected by these plans and that we would not be affected by the noise, mud and disruption during construction, plus overshadowed by the mast etc.. We expect protection from the N.Y.M. Planning Dept. which is sadly lacking when I am told by Mr Ulliott, that it was the planners that suggested this site would be the best place. For who may I ask, not for the resident home owner!

I believe that the proposed plans are flawed they are still very visible, they must still contravene the previous objections, plus the effect it would have on my home in terms of invasion of privacy, the devastating visual aspect from my home and the devaluation of my property.






- 1. View East Farm inside garden vegetation with clear view through to proposed mast site
- 2. Inside garden shows clear view of proposed site plus 6ft step up to field, holly bush on right needs to be cut back to tidy it up (not done for 2/3 years).
- 3. View from field towards our garden, showing site would be visible from the gardon.
- 4. {Brush I want to clear this year to let light in and open views of the fields and sheep.
- 5. {
- 6. Elevation of our hedge, access road would be against this and would be a scar on the hillside impacting on East Farm.
- 7. Previous proposed mast site rejected.
- 8. Where the access road would come up the hillside by the hedge from the entrance gate and turn left along the line of hedge
- 9. Uphill along the line of the hedge to underground reservoir (closed) East Farm in background.
- 10. Turn right along reservoir fence.
- 11. Turn left along East Farm Hedge, field is over 6/8 ft. higher than East Farm and soil is unstable!
- 12. Uphill along E.F. hedge line, again field is higher and ground could be unstable.
- 13. Left with hedge line to where the mast, large concrete base, cabinets, turning for vehicles would be sited note land fall.
- 14. Fall of the land to corner of proposed mast site land very spongy
- 15. &16 Fall of land above tree line and undulation of field.
- 16. Corner where concrete base would be located, land is already spongy.

The site work noise and disruption so close to our property would be intolerable together with the mess, possible subsidence on our boundaries, garden flooding due to the construction of a large concrete base disrupting soak away and surplus water into our garden.

I shall fight this plan and use every avenue to object if the plan still went ahead to planning committee with your approval. You cannot treat residents in this way, we need consideration not D. Ulliott who lives at Suffield and is quite happy to take the money and see the mast put up against my home far away from his house, or a phone company, who are unable to find another site especially that you have already recommended well away from dwellings.

The irony is I could have bought the fields with my house, but I did not want them, I saw no need to buy them as a safety net, after all the planning regulations in NYM are very strict and there could not be any construction on farming land in the Park, or so I thought. A decision I could regret.

A notice relating to the above application has been displayed on Keld Runnels Road at Scalby Nabs, for erection of BT distribution poles.

Whilst I have been a resident here, BT have in the past, removed all the poles which carried communication lines the length of the Nabs and ducted them under the lane. one reason being, the "shoot" which operates up here was damaging the cabling !

I am objecting to the new site location of the mast. A road to service the installation of 320m x 5m is too long and will cover and spoil the "original pasture" in the field. Building a road alongside a residential property for some conciderable distance is not acceptable. Mature trees that are expected to screen the mast and ground installation could be removed, exposing the site completely as they do not belong to the landowner of the site. On site electric generation and auxilliary equipment will be a noise nuisance to residents as it is near their boundary and too near property. There is no mention of mains electricity. If this is required at the installation, will it carried by overhead cables creating further eyesores at Scalby Nabs ?

In the field are Neolithic stone carvings (see attached image file) 3000 years old and need to be protected and perhaps it would be prudent for an archaeologist to visit site as these carving are the best I have seen in the area.

Surely there must be a better site and with the mast backing up to woodland and well away from property.
