## Proposed Landscaping Plan – Building at Selly Hill Farm

Along the western boundary of the proposed building, we suggest planting three rows of mixed species native trees and shrubs of varying sizes and ages to provide food sources and winter cover for birds and other wildlife as well as working to the enhancement of the environment and providing screening for the building. Planting a variety of size and age of trees and shrubs will allow for quick screening of the proposed building and create a diverse and resilient native woodland.

- 5m to the west of the proposed shed one row of silver birch planting density one tree per 5m. Planting size 150 -240cm (depending on availability) deer guards 2 x stakes per tree.
- 7.5m and 10m to the west of the proposed shed two rows of oak, holly, hazel, field maple, scots pine and rowan. Planting size 15cm to 60cm bare rooted or container grown plants (depending on availability) planted a 2m apart within the row and 2.5m between rows.

Please note there are no existing hedges/ trees on the site or neighbouring the site of the proposed building.

I would be grateful if you could acknowledge receipt of this information and let me know whether there is any further information you require. Please note I have not yet heard from highways regarding the access.
