The Old School House at Fylingthorpe is one of the better preserved buildings I have encountered in the North York Moors National Park. The application seeks to refurbish this building as it has clearly been neglected for some time. One of the few changes to this building is the installation of two rooflights to the main bathroom, one each on the front and real elevation. It is not clear when these were installed and could date prior to listing, and therefore authorised. I would however, note that that are metal conservation Velux rooflights of a type that is no longer sold. When the time comes for their renewal, they should be replaced with metal rooflights, not the plastic conservation style that Velux now produce.

I am pleased that recommendations made at pre-ap have been followed. As a whole the proposals are an exemplar of how a listed building should be treated. There are minor changes to the property but they are limited and mitigated to a satisfactory extent. As such I support the proposals but ask that the following conditions are applied. Regarding the mortar and plaster, I approve of the approach to use a hotmix, but for the sake of clarity I will need to assess the mix.

All pointing in the development hereby permitted shall accord with a specification approved in writing by the Local Planning Authority, which includes mortar mix (based on a typical mix of a non-hydraulic quicklime mortar mixed at 1:3 (dry non-hydraulic quicklime: sand), method of application, finish and may include a sample area if so required by the Local Planning Authority. The pointing shall thereafter be so maintained unless otherwise agreed in writing by the Local Planning Authority.

No work shall commence on the installation or replacement plasterwork, limewash/paint finishes and insulation in the development hereby permitted shall accord with a specification approved in writing by the Local Planning Authority, which includes a traditional lime mix, method of application, finish, details of function and may include a sample area if so required by the Local Planning Authority. The plaster shall thereafter be so maintained unless otherwise agreed in writing by the Local Planning Authority.

No work shall commence on the instillation of ventilation to the roof of the development hereby permitted until details of the roof tile, including samples if so required by the Local Planning Authority, to be used in the development have been submitted to and approved in writing by the Local Planning Authority. The roof tile used shall accord with the approved details and shall be maintained in that condition in perpetuity unless otherwise agreed with the Local Planning Authority.

Could planning also include an informative regarding the installation of the wood burning stove? This should state that should any historic fireplace be found behind the boarding then is should be retained in situ. I would have no objection to this being boarded over as existing and a wood burned installed to the front. Removal of a historic fireplace would require further LBC and is unlikely to be supported.
