Thanks for this, very helpful. Yes, I was consulted on 2021/0087/CVC, which this applies to, but the documentation didn't include the WSI, only mentioned it. Luckily a Project Manager from Cotswold Archaeology has already had the initiative to contact me directly about the Ladycross works, and I have discussed the WSI needs over the phone with him.

The document you have forwarded to me shows that Cotswold have taken my comments on board, and I can now confirm that it meets the needs for the watching briefs at this site. Thank you for your understanding.

Arup are amending the site clearance drawing to better reflect the limited area of tree clearance and as soon as this is available I will get it appended to the CEMP and uploaded. This may be later today or possibly Monday but I will drop you and email to let you know when it is done.

On another point, condition 33 (Scheme for Prior Notification of Blasting) was fully discharged on 19 November 2018 in Phase 7. The report has recently been updated to align with Anglo American branding which has meant a change to the website address within the report. There are no other changes to the content of the report.

In the approved version, you are directed to www.siriusminerals.com. The revised website address is uk.angloamerican.com. If you type www.siriusminerals.com into your browser bar you are redirected to the Anglo American Woodsmith project website. I attach the revised report for your information.
