# Proposed changes to the exhibition, interpretation & education offer at the Old Coastguard Station Exhibition

The proposal outlined below is to help improve the visitors experience and education offer at OCS and make maximum use of the buildings space. On the ground floor there will be a welcome desk where visitors will be welcomed and guided by the service assistants as to what's available for them to see over both floors of the building. The ground floor will retain interpretation for visitors to view but will also double up as a small café/take away and seating area. We believe that this offer will naturally draw more people into the building, enabling us to provide a great service and engage the public in the work we do across the coast.

The **Service Assistant** role is all about delivering outstanding customer service to a broad range of visitors and doing everything possible to make sure they have a great day. Duties range from welcoming and admitting visitors, promoting the coast and its nature value and the conservation work we and our partners do.



The space is fully accessible via a lift and staircase from the ground floor and will be more flexible and allow us to talk about our projects and the partnerships that manage and care for the coast and will provide key messaging about respecting the coast and wildlife. Digital screens, audio and interchangeable interpretation methods will let us keep this information current, relevant and engaging.

In the lobby area there will be more of an emphasis on the history of Robin Hood's Bay, the building itself and the role it played and still plays in the community and for visitors. Local leaflets and posters promoting attractions and events in the area will be available in this space and helps us retain the information centre aspect of the building. The ground floor exhibition space will become multi-purpose. There will be a limited number of indoor seating attached to the Food & Beverage offer. The interpretation in this space is built out from the walls so removing it opens up a much larger space as well as uncovering a closed door and window allowing visitors to experience a true version of the building and being able to connect with the history told in the lobby area.

The space will be used for local artists to exhibit as they do now in the first-floor room. There's also the opportunity for us to work more closely with local artists and showcase their work more regularly in this space on their behalf.




The bird spotter panels in the window alcoves and binoculars will remain and information on the Jurassic coast and dinosaur footprint cast will be displayed in this area.


The fish tank is being removed permanently but we will still provide information about what people can find in the rockpools and the education packs will be able to be used by all visitors to help them to experience it.

Utilising the space in this way enables us to engage with a larger audience and better promote the area their visiting as well as the work the charity does in conserving this incredible coastline. The café will provide a more positive contribution to the work we do on the coast and enable visitors to relax and unwind with a tea and cake while they contemplate their next adventure.

## **Revised offer**

A back pack with the relevant equipment for the activity, each pack include pencils, nets, identification and tallying sheets for the kids to keep track of what they find. A session plan for teachers in advance (attached) and a booklet for on the day and additional activities (attached).

A session looking at how plastics and climate change are affecting our coast and some practical litter picking around the bay.

## **Bird watching**

A 'back pack' offer like rockpooling
