We are not developing a holiday complex, with this in mind there is no need to have a store room and holiday rental office adjoining the main farm house, our plan is to use this area as a kitchen dinning room with one addition skylight window and glass bi-folding doors. A Air source heating pump will supply heating and hot water, the condenser will be located to the side or rear of the property (TBC by supplier) this to be screened by a dry stone wall or composite board. The loft space will be converted into a bed room with ensuite bathroom with three sky lights fitted to the rear elevation of the roof. Landscaping plan will change due to the lack of holiday accommodation being built
