Unfortunately I can find no record on our system of such an enquiry so I guess it was probably a quick phone call. My understanding is that whilst the putting in of a means of access i.e. making a gateway into the field from the road was permitted development under the TCP (GPD) Order 2015 Part 2 Class B, the access track across the field to the farm would have certainly required a Prior Notification under the TCP (GPD) Order 2015 Part 6 Class A if it was solely for agricultural purposes. Unfortunately you cannot submit a Prior Notification retrospectively so the track should be included in this current application.

In addition I have just received comments from EHO at Scarborough Council who have requested details of how waste water will be managed or treated within this rural locality.

Thank you for the amended drawings in respect of the proposed building which I have forwarded to our Planning Administration team to book in. As the floor area has been reduced there is no requirement to satisfy Policy ENV8.

With regard to the access track, this does not show on our most recent aerial photographs and from your email it is likely that this track is unauthorised and requires retrospective planning permission if the intention is that this will serve the proposed caravan site. As such it should be included in the red edge of the application site for the entire length from the public highway. As the access is existing, any damage has already occurred to the trees; providing no further work is required to the access track then a tree survey is unlikely to be required however I shall seek the comments of our Woodland Officer once I have had the opportunity to visit the site.

On this note I am unsure when I shall be able to visit although hopefully in the next week or so. So as to avoid any further delay I wondered if you or your client were able to print off, date and display the attached site notice please at the end of the farm access on the public highway? If so I would be most grateful if you could send me a photograph to confirm the posting of the notice.

As the case officer I have been asked to respond to your email. I have only just received your application and as such have not had chance to assess the proposals in full, and it may be that matters become clearer once I have visited the site. However the site plan submitted shows an access road running in an east-west direction across the southern edge of the proposed caravan site but this is not shown on the OS location plan and does not appear on our aerial photographs of the site. It is not clear from the site plan what this access road links up to and whether it is a new access from the public highway to the proposed caravan site. It also lies outside the red edge of the application site. As such I would be pleased to receive additional information/clarification regarding this access road along with a revised red edge to the location plan.

This leads me to the requested tree survey. As the access road clearly passes through the middle of the small woodland to the west of the farm a tree survey is required so that the impact on the trees can be fully assessed. We will also require constructional details for the proposed access road.

With regard to our request for details of how it is intended to displace 10% of predicted CO2 emissions from the development, this is a requirement of Policy ENV8 which requires proposals of 200 sq.m. or more to generate energy from on-site renewable sources. The policy does not differentiate between internal or external floorspace and I would suggest as a swimming pool with associated showers and toilets there will be a high level of energy use. As such this policy does need to be met.

I look forward to hearing from you in due course.

In response to your email dated 12th April 2021.

Point 1. I will confirm the drainage shortly.

Point 2. As we are not building anywhere near to the trees, is this really necessary? The hardstanding for the caravans which is nearer (12m from the nearest tree trunk) will be formed from gravel and is located far enough away from the tress to not cause a problem.

Point 3. The building is 10mx20m measured externally therefore it does not create over 200 square of useable floor space.

Please let me know your thoughts on the above.


