Thank you for the confirmation that your client wishes to withdraw the application however I should draw your attention to the fact that the track is unauthorised and does need to be regularised. In its present form it does have an adverse impact on the landscape and biodiversity of the National Park and as such the Authority cannot simply ignore it. Should this current application be withdrawn then I would have to refer the matter to our Enforcement Team who will no doubt seek to resolve the matter with a retrospective application which will incur more cost to your client. As a way forward can I suggest you simply withdraw the caravan site and swimming pool building and provide an amended block plan that indicates a commitment to native hedge planting along either side the track to soften its impact and compensate for the loss of biodiversity and I can include a condition on any planning permission requiring full details of the planting scheme to be submitted within 6 months so that planting can take place in the next planting season (Nov 2021 – Mar 2022)?


