I speak categorically as a member of the public, and not on behalf of the BBC, but I believe my recent role, as the producer of a one-hour documentary on the North York Moors (*A Wild Year: North York Moors*) may offer a valuable perspective on the business Mrs Barraclough has built at Dalehead Farm and how it is perceived outside the region. I hope this letter goes some way to demonstrating the value of this business and the recent changes she has undertaken, not just to the Barraclough family, but to the North Yorks Moors region as a whole.

As makers of natural history programmes, we aim to capture on film, a true sense of place. Our job is not only to transport viewers to beautiful parts of the world, but to try and distil a place's unique combination of wildlife, history, landscape, people and culture into a single hour of television. When I was tasked with producing a programme which was to follow the changes that take place on the North York Moors through the year - a place I had visited only once - I was daunted by the prospect of capturing the essence of the region. What was needed was a central hub, to which we could return frequently through the year, which somehow encapsulated the cultural heritage of the region. It was less than an hour after arriving at Dalehead Farm that I realised it was the perfect place.
