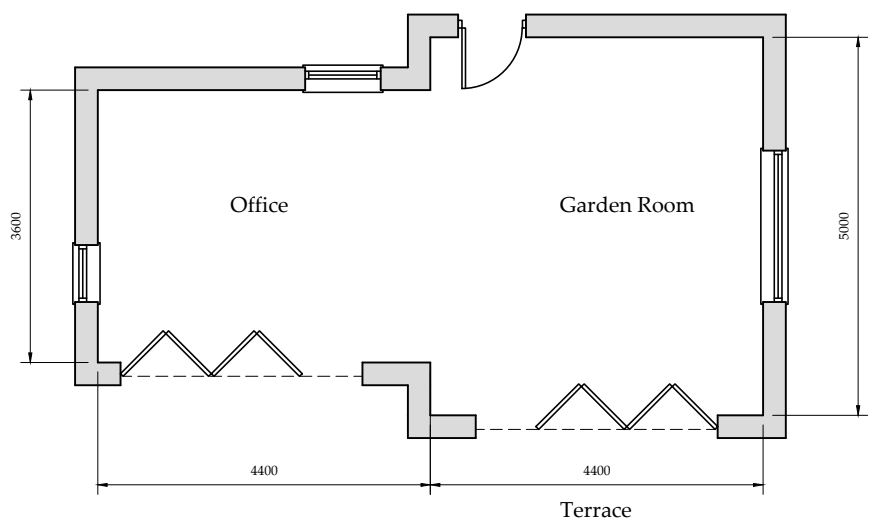
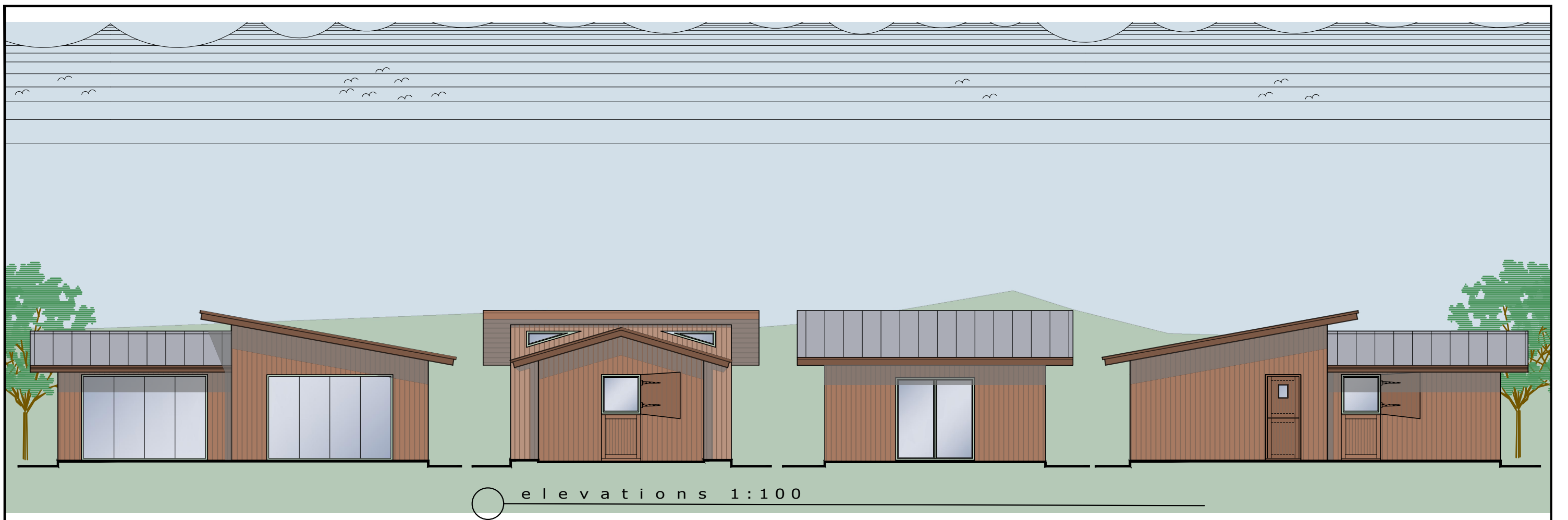

Sorry for the delay in responding.
However we have now discussed this with the clients and produced an alternative design.
It is single storey, and simpler in design.

The glazing is substantially reduced and mainly looking South East.
The other elevations are much plainer with timber boarding and minimal glazing more styled to replicate the previous stables.
As suggested this will be significantly more subservient to the Main house.

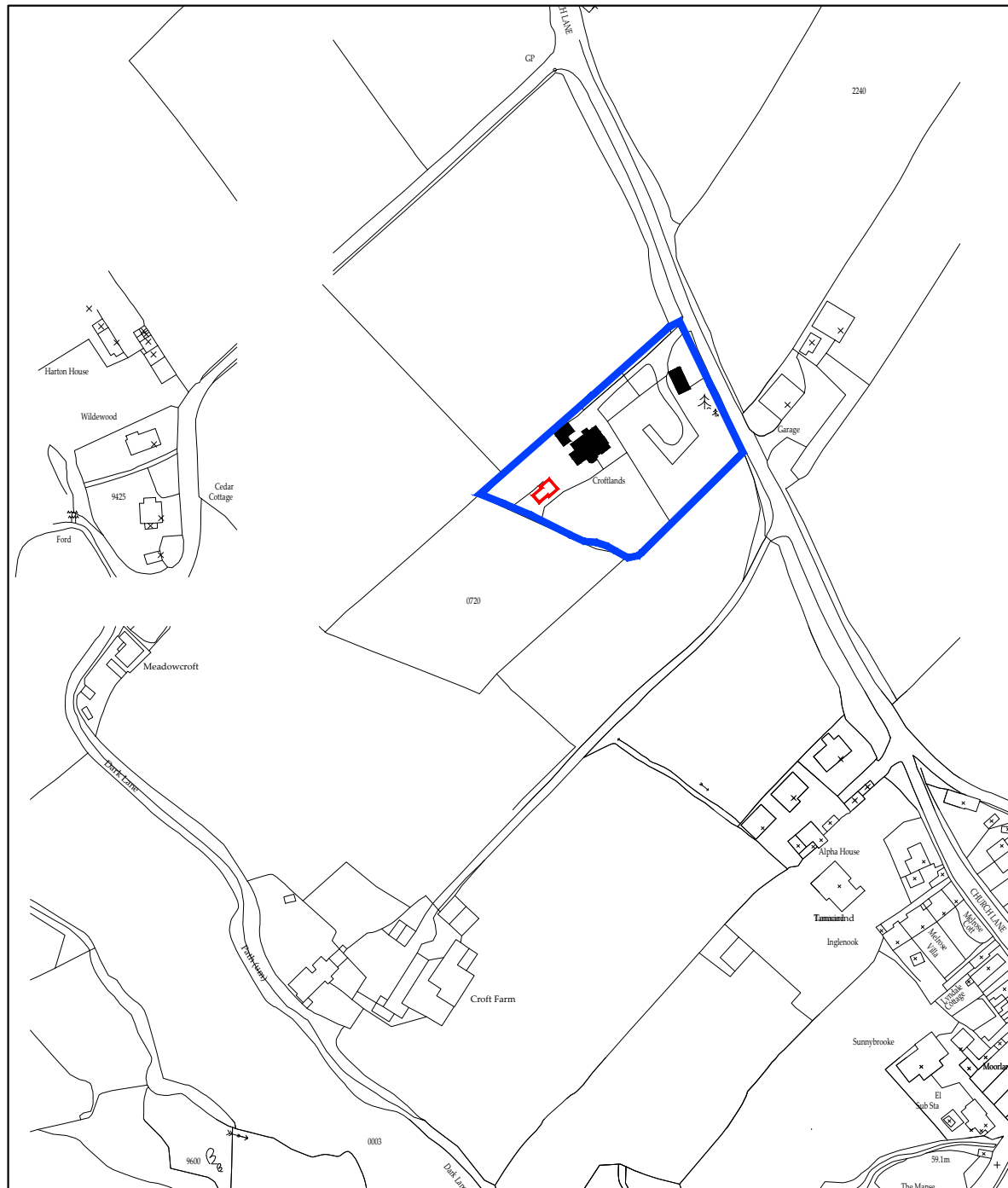

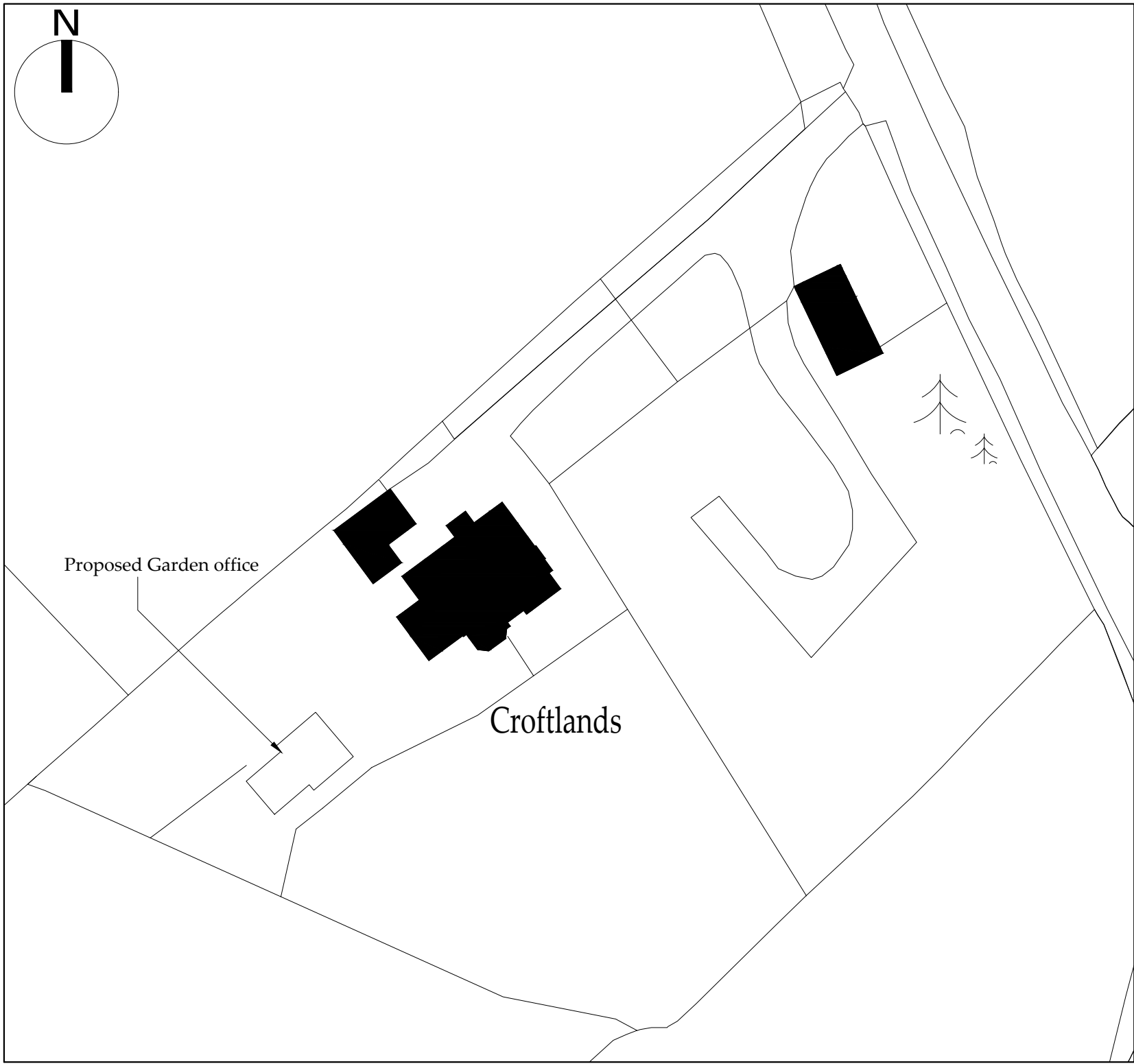
