In assessing the submitted proposals and reaching its recommendation the Local Highway Authority has taken into account the following matters:

The size of the garage is below the minimum requirement for this space to be classed as a suitable vehicular parking space. The proposals are not altering the likely demand for parking at this address nor are the designs reducing the off street parking availability.

If the applicant wished to apply for widen the extent of dropped kerbs, it should be noted that this will require planning permission as it is on a classified road, but this has not being included within this application and therefore, vehicular access should be across the existing footway crossing rather than driving over the area in front of where the front wall has being removed.
