"We intend to install a composting toilet in each shepherds hut, all waste from the toilet will be contained within a sealed chamber installed in the hut, the waste will then be emptied and removed off site by licensed professionals. We do not intend to use any toxic chemicals, bleach, etc in the huts and will provide environmental friendly cleaning products and toiletries for each guest. We would happily chat to Elspeth if she requires any further details and are willing to take on board any requirements as she deems suitable."

Given the off grid nature of this development, I don't have significant concerns with it. I note thought that it is mentioned that waste from each hut will be collected and composted 'elsewhere on site'. Given the proximity of the land in question to field drains, Sunderland Beck and a grassland area of interest immediately eats of the site, it would be helpful to get more clarity about where this will be located and how this processed. It would be useful for example to get a commitment that only biodegradable wash products will be provided/used to ensure lasting chemicals are not introduced to the composting system.
