I would be grateful to be given the opportunity to be able to comment on my support for this application. I see the benefits of the resiting of Noble Recycling and Skip hire, from two different points of view. From a business point of view the current location of the operation is not ideal as it is somewhat constrained by both geographical and logistical issues. During the initial phase the operation seemed well placed, as it formed part of a site from which an existing transport and warehousing business was already operating from. However, as the demand for the services which the business provides increased exponentially, then the need to expand in line with this became more and more of a requirement. In order to be able to fulfil the needs of the ever increasing customer base, and to be able to offer the current headcount of colleagues and any potential increases in employment opportunities, a more secure and sustainable future, then the time had come to look for a further, more substantial operating centre to enable the processing and recycling of more waste.
