Hello please note block plan of driveway inc guest parking area in green showing proximity to house and stable block.

A very large turning and parking area.

I will be fitting new lights to the shepherds hut this weekend and will send details as soon as complete,

These are Matt black conical fittings which only emit downwards light as do external lighting on rear of stable block to illuminate footpath to access toilet.

Guests will be provided with a dimmable lantern which is rechargeable so not contributing to any spent batteries .

Dear Mr Coulson

Thank you very much for your prompt response to my letter yesterday. I note your comments in relation to the original design of the coach lights and the existing lighting issues in the vicinity.

In response, I would advise that the Authority has little control over existing lighting but since the designation of the area as an International Dark Sky Reserve in December 2020 the Authority has sought to improve the quality of proposed lighting and also worked with residents and businesses to improve existing lighting which is considered harmful. It is certainly not desirable to contribute further to existing problems and a greater level of control has been possible since the adoption of the new Local Plan which contains a specific planning policy relating to dark night skies, aiming to maintain and where possible enhance the darkness of our skies at night.

In view of the above, I would recommend that you give consideration to alternative lighting for the shepherd's hut or to investigate other ways to modify the existing original lamps to be more compliant with the policy requirements.

Alternatively, if you would prefer to retain the lighting as proposed for Member's consideration, please advise and I will ensure the justification you have provided is included in the report.

Having regard to other matters, I would be grateful to receive a copy of the proposed parking plan as requested in my letter.

Finally, I note your desire to speak at the meeting however, the booking facility is not yet open. You will receive further correspondence from the Planning Administration Team on 20 August 2021 which will provide further information about the Committee process and details of how to book a public speaking place.

I trust the above is of assistance to you and look forward to hearing from you further in due course.
