Hi, Mark,

Just a quick note to let you know who we are and why we exist.

We are a small group that formed to stop inappropriate development on the local common (**CL0063**). As a result of our campaigning, we were added to the government list of consultees on common land in 2004. Because of this the North York Moors National Park Authority makes our group aware of any planning application that has implication for common land.

1. First, the lighting. We should not have made the comment. Apart from being unclear, it does not relate to common land and our policy is that, as a group, we only comment on common land issues. Any further comments our members wish to make on a planning application must be made individually. It would have been appropriate to make the Parish Council aware of the group's concern over the growing urbanisation of the village--the footpath being one instance and street furniture another. It looks as if a trend is developing.

2. It would appear from your letter that our views on the use of common land differ slightly. Common land usage in a town or city is very different from common land usage in a rural situation. We accept the road safety aspect, but your comment "the area of common has become very overgrown" rings alarm bells. "Overgrown," "unused, " "just wasteland" have all been put forward as reasons for developing the common. As I'm sure you are aware, a desire line appearing on a common is a reason to consider whether a footpath is necessary. As the area is overgrown, this is not the case. When farmers are encouraged/paid to leave headlands and the BBC constantly promotes leaving at least some if not all of our gardens to go wild, we should not seek to mow the common.

3. Road Safety--we don't disagree--a footpath, if used, would improve safety.

4. The Funding--More unnecessary projects are started to clear the budget before the end of the financial year than I care to think of. I'm sure you have seen it even if most parish councillors may not have. I would like to see costing for the maintenance and whether anyone can even be found to maintain the area. Parish councillors doing sterling work with strimmers along the High Street would suggest a problem in one of those areas.

5. Removal of Objection. Although our original communication with the NYMNPA stands, it is not an issue we intend to take any further. It cannot be disputed that the section of road is dangerous to walk--the area below the tennis court is particularly bad as vehicles are travelling at a greater speed. We are, however, of the opinion that as in the case of the wonderful trods that exist around Glaisdale, the path will be unused and so will disappear over time.

#### Note to the Planning Officer:

In assessing the submitted proposals and reaching its recommendation the Local Highway Authority has taken into account the following matters:

It is considered that the "maintainable highway at public expense" (MH@PE) verge extends for a width of approximately 3 metres at both ends of the proposed footpath.
