Dear Megan,

This location is rural with very little light pollution nearby. The amount of glazing proposed in this application is excessive, risking a drastic increase in light spill which is not in accordance with our dark skies policy. I would ask that in the first instance the applicants reduce the amount of glazing in their proposals. If that is not possible they will need to take measures to reduce light spill from the windows on the proposed two Storey rear extension. i.e. through film on the glazing to reduce the amount of light escaping from internal lighting (without reducing passive light from outside in). This should be considered prior to the reliance on blinds/curtains which are of course dependant on human action to be effective.
