

Design Access Statement

Fisherman's Cottage

Replacement of Windows

We bought Fisherman's Cottage late 2017. The windows had been freshly painted for the sale. After having trouble opening and closing some of them it became obvious over the course of our ownership that the windows were really in a poor state of repair.

We employed a local joiner/handyman to see what he could do as some of the hinges were coming out of the wooden casements. He found the wood to be too rotten to repair. We have subsequently wired the windows shut for safety reasons as we fear that there is a real potential for the part of the windows that open to fall away, posing a major public safety risk.

We have a joiners' report on the windows from Norton Joinery specialise in this area and they have confirmed that replacement is now the only option. We have a quote from them for doing the work from them and we have stressed the importance of "like for like" replica windows in accordance with Listed Building Consent regulations. They have assured us that this is something they will do for us and that they often do the same for other clients.

Re: Fisherman's Cottage, Robin Hoods Bay

We have undertaken a survey on the five flush casement section windows to the front elevation at the above property in Robin Hoods Bay.

The windows are showing signs of severe decay, with most of the decay going from the outside to the inside of the window frames.

The hinges on all of the opening sashes have rusted away so the opening sashes are unusable because there is a risk of them falling off and severely injuring a passing pedestrian.

Many of the opening sashes are painted up rendering them unusable.

The property is situated in the dock area in the lower village and new windows, which will be manufactured to be a copy of the existing windows and which will now incorporate weatherseals, will significantly help reduce heat loss and also reduce noise in the property.

In our expert opinion the windows are beyond repair and need replacing with new.

The windows will be factory glazed with 4mm clear single glass externally putty pointed.

The windows will be constructed in sapele (hardwood).

All factory applied with an Anker Stuy Hydrolux semi-gloss top coat spray paint finish (colour to be confirmed).

Notes.

- Due to market conditions and stock availability, all estimates will be subject to final confirmation at time of order.
- Top coat paint finish is based on the same colour inside and out. A split finish will incur an extra cost.
- Putty will require painting on site by others once cured.
- The scaffolding required for the installation of the windows will be arranged by you.
