As this development proposal will include less glazing than existing to the conservatory I do not feel I can object to the amount of glazing proposed. This proposed development is in an extremely rural area so any efforts from the applicant to minimise upward light spill to reduce potential impacts on dark sky qualities would be welcomed.
