Proposed planting scheme for boundary to garden extension at Suffield Cottage, Scarborough, YO13 0BJ

In addition to the post and rail fencing along the new boundary line, the intention is to plant a mixed hedge of native species to screen the garden, providing year round interest, and to encourage wild-life habitats through the choice of planting.

The proposed planting ratio is 50% Hawthorn, infilled with each of the other species listed below.

- Hawthorn 50%(Crataegus monogyna)
- Bird Cherry 10% (Prunus padus)
- Field Maple 10% (Acer campestre)
- Dog Rose 10% (Rosa canina)
- Hazel 10% (Corylus avellana)
- Blackthorn 10% (Prunus spinosa)

Hedging plants will be bare rooted, and therefore planting is advised between November and March.
