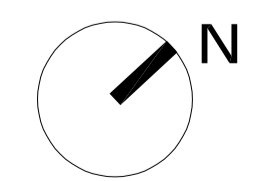

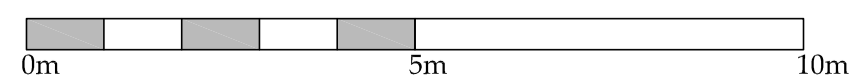
○ Side Elevation South West
