- 1. The existing carpark at rear of Fox and Hounds could be used to install proposed electric car charging spaces thereby removing the need to dig up and destroy a much needed large green space in the middle of the hamlet.



I am a homeowner who resides at 5 Slapewath Cottages and have concerns about the proposed development. I feel that what is proposed has no place in a small hamlet or if there is actually any demand for the facilities. I also have concerns with regards to the effects on wildlife in the area, the extra litter that would be created from such a venture, as well as noise pollution and added light pollution.

Residents of Slapewath also have repeated issues with on street parking due to congestion caused by inconsiderate parking when people visit The Retriever and others who walk The Cleveland Way which passes through Slapewath. I wholeheartedly object to the proposals for the green at Slapewath.

Slapewath is a small hamlet comprising of 6 residences. The green in the middle is the only green area in Slapewath. It houses wildlife and trees, in a lovely peaceful setting.

There is no need for a kiosk to provide amenities. Between them, the Retriever Bar and The Chase are open 9am til 11pm 7 days a week. Providing hot and cold food and drinks as well as toilet facilities. The hotel guests have microwaves, fridges and kettles in their rooms.

A further facility with extended opening hours would merely cause disturbance due to noise and lighting, to the residents. There would be extra rubbish, that in turn could attract vermin.

There are shops and takeaways less than 2 miles away in Guisborough.

Whilst charging facilities for electric cars may be useful, again there are many charging points available in the nearby area. If these were deemed necessary in this area, then there is a very large concreted car park that has lighting, to the back of the hotel, which would be an ideal position that would not disturb anyone.

The "building" that is being proposed to charge bicycles, is in fact an old shopping trolley shelter from Sainsburys and not an actual building.

Our environment is a way of life and is respected and understood by the existing residents. The conservation of the character, distinct identity, and value of the community's green open space of the National Park is at risk of erosion and threatens its natural beauty which is appreciated by the community, tourists, wildlife, and protected species i.e., bats We feel a need to protect and conserve our green areas and the local people of the community should be involved and take the lead in shaping their neighbourhood.

Julie Iseton, I am the proprietor of The Chase Café, adjacent the Fox and Hounds Hotel and I Object to the proposed Planning application NYM/2021/0722/FL

I feel there is no need for a Café/Kiosk to be sited on the green land in front of The Fox and Hounds Hotel, The Chase and The Retriever Bar already cover the facilities required by hotel residents, tourists, walkers, and residents of Slapewath and the surrounding villages. The Chase opens at 9am, this was a decision made after covid, considering covid restrictions and lack of footfall before this time. The hotel guests have the use of a refrigerator, microwave, tea and coffee facilities and a toilet in the rooms to enable them to self-cater should they wish to do so. The hotel also provides a continental breakfast on request; therefore, they do not have a need for any other facilities before reasonable opening hours. Should the guests request breakfast before 9am I have no objection to opening before my usual opening hours. From opening up after covid in May to the present time, a seven-month period, I have been requested to open at 8am on two occasions therefore in my experience there is not a call for my opening hours to change at the present time, should the situation change, I will certainly reconsider my opening hours as why would I turn down an increase in business.

My USP is coffee, cold drinks, sandwiches, and snacks. The kiosk will be direct competition for my business which may lead to a loss of business therefore a need to reduce the number of staff I employ due to a downturn in business as the tourists and walkers may choose the cheaper takeaway option available from the kiosk. Tourism is seasonal and has an adverse impact on our business, the qualities of the area draw people to us and taking away the green space will detract family visitors.

The kiosk will create noise pollution and litter. Should the kiosk be open, as the Fox and Hounds employee has stated, out of the hours of the current businesses, which would be from before 9am in the morning and after 11pm at night, this will create antisocial activity with no respect for the Slapewath residents. I am unaware of the number of staff the kiosk is proposing as the applications states 2 fulltime and 2 parttime, whereas on the Drainage Assessment Form it states 2 parttime?? And the hours to be worked are unknown.

The existing businesses already generate traffic without generating additional traffic causing a danger to pedestrians, children, horses and dog walkers which frequent the Cleveland Street walkway.

This area is also a hazard in the winter months, the snow and ice cause a dangerous access from both exists of the hamlet, a very problematic accident hotspot on the A171

Climate change brings with it extreme weather events as we have experienced over the years i.e. November 2016 flood water reached over 1M high. We are susceptible to flooding, rated High Risk for surface water flooding on the Gov.com

We value our business, our customers, our neighbours and respect our environment, therefore urge you to refuse this application.

Parking area with electric vehicle charging bay, café/kiosk building to land at the front of the Fox and Hounds

As <u>residents</u> of the small hamlet of Slapewath, on the outskirts of Guisborough on A171 Whitby road, we would like to object to the proposal of the construction of a parking area with electric vehicle charging bays and a kiosk and toilet on the green belt of land in front of the Fox and Hounds hotel. These proposals were not made known to the residents of Slapewath and we only discovered them by happenchance and that is disappointing and makes somewhat of a mockery of the so-called 'consultation' process. The proposals as they stand are less than convincing, they are not fully explained or developed in what has been submitted and in what is publically available to view, and we strongly object to them being approved in their current form.

Slapewath is a hamlet with houses facing directly on to green space that the proposal refers to. The proposal to build on the green space and install car parking charge points, a toilet facility and kiosk would constitute a significant change to the area and without question negatively impact the quality of life of residents both in Slapewath and the surrounding areas. Green spaces, particularly in small hamlets are very important to residents and to the abundant wildlife that live and nest in the surrounding space. The proposal has as its starting point a concern for the environment but the attention to environmental impacts is woefully underdeveloped and simply unconvincing. Whilst the proposal states that the kiosk will be designed 'to fit into the environment around it' it is difficult to see how this can be achieved. The application makes clear that there are trees/ hedges in the area to be developed but it is not clear that a full tree surgeon's report has been undertaken to show the impact of the development and how this will be managed (and this seems to be required for planning to proceed). There is no real mention of impact on the wildlife in the area or management of increased waste and rubbish that will no doubt be left in the vicinity. It should also be noted that several adjustments to the green area have already been undertaken by the proposer, and I'm afraid in our view it would be difficult to view some of the additions as enhancing the green space. We can see that one of the other local public responses on this proposal mentions the supermarket trolley bay that is masquerading as a train, but there is also a old, very large plastic elephant, and several other very old playground items that are very obviously not fit for purpose and do nothing to enhance the look of the green space or offer meaningful opportunities for children to enjoy the outdoor space. There is a large car park at the back of the pub/ hotel that is currently not well utilised, although it could, with some work, potentially provide a space for the sorts of electric car parking charging stations being proposed. Cars are often parked outside the residences in Slapewath, particularly on a weekend, as parts of the car park are frequently out of use of due to piles of unsightly and unhygienic rubbish, along with several large shipping containers that have been in the car park for some years. The current disrepair in respect of the play areas and the rear areas of the hotel do not lead us to have any confidence that a bigger and more ambitious project of this nature is likely to be successful.

The proposal of electric cars and charging bays is a good idea for the environment, although there is very little evidence of sustained demand for this in the region at the moment and the proposal only makes reference to some *informal* comments from a few hotel guests. We would have expected to see clear factual data and evidence on the uptake of electric cars in the region and indeed some

proper indication of the wider demand if this proposal was to make convincing reading. As such, and as the proposal says nothing to convince us otherwise, we can only assume demand for the charging points will be somewhat limited, at least short term. In the longer term we would likely hope to see an increase in demand but we will also inevitably see greater uptake of charging points by large businesses in the region, for example supermarkets, which will be better equipped in terms of access and space for charging points and where people will find it simpler and more convenient to charge their cars.

The changes to the green area and the proposal for a kiosk and toilet are much more concerning. These two developments are likely to bring significant additional traffic (most likely not of the electric sort) and which will without any doubt negatively impact the quality of life for residents. The A171 is already an extremely busy road and recent years have seen a very significant increase in articulated vehicles with the construction of the mine further along the road. The speed and volume of the traffic is already frequently unacceptable and a risk to people crossing the road. This is a busy intersection of road with people catching buses, walking on the Cleveland Way and accessing other parts of the national park and for road users in general. The speed of the traffic already constitutes a risk for the two road entry points into Slapewath and we have witnessed several accidents in the time we have lived here (five years). The entry points are also not well suited to large vehicles, particularly coaches that frequently struggle with access. If the proposed new facilities are meant to be meeting an unmet need in terms of the demand for a kiosk presumably the opening times would be clearly known / planned and mentioned on the application. The proposal states that the opening hours are unknown and that is incredibly vague and worrying. In the light of no clear information we have to assume that the kiosk would be open late (during the night?) when other businesses selling food are closed. If this is not the case, then the other food businesses will be negatively impacted and if this is the case it is likely to have a significant impact on the local environment (increased traffic, anti-social behaviour and noise during unsocial hours and when most residents will be in bed). It's a small point but the proposal talks about two full time employees and two part-time that is then presented as one whole time post but elsewhere it talks about two part time staff only. Perhaps a simple mistake, but again this is not suggestive of a thoroughly thought out and worked through proposal.

The toilet development is of particular concern. I'm sure you will be aware that there is now, perhaps more than ever, a huge demand for public toilets at a time when many have been lost through cuts to local services and very few are available during the night. I can see in the public documents that concerns have been raised about the toilet and the disposal of waste and the narrative in the application stresses the toilet will be primarily for people charging their cars. Whilst demand for the electric charging points may be limited in the short term, the demand for the toilet is likely to be far greater. As the application states we are ideally located for passing traffic and walkers using the Cleveland Way so there is a very real danger that the toilet will become the 'go-to' toilet for walkers and the increasing number of articulated trucks using the road during the night and for buses and coaches (larger vehicles would not be able to access the road from the entrance put forward on the plans and regularly struggle to get down to the hotel/ pub area due to the volume of parked cars on the bank). It is clear from the papers on this proposal that the drainage system will not be up to the job of anything more than a small number of toilet users and as the response to this particular concern implies volume of usage is not something the proposer will have any control over. The idea that the toilet would be used occasionally 'by other users' is completely unconvincing to anyone who lives here and regularly witnesses the sheer volume of traffic on the A171 and the numbers of walkers and cyclists passing through on a daily basis (if you are interested the traffic increase you can find more detail here and you will see that there has been a large increase in traffic

on this stretch of road over the last decade, with a particularly steep increase in respect of buses and coaches https://roadtrafficstats.uk/traffic-statistics-redcar-and-cleveland-a171-guisborough-60074#.YaabqS2cZ-U)

It should also be noted that the internet connection in Slapewath is consistently poor and you only have to look at the nationally available data to see that in comparison to other areas the speed of the internet at Slapewath is woefully slow (https://www.broadbandspeedchecker.co.uk). Unless Mr Hussain plans to invest in improving the connection (which can be done for a price and would have been good to see in the proposal) it is misleading to advertise this as a strength in the proposal as that is simply not reflective of the reality.

Overall, we very much oppose this development of the green area. We are not against the electric charging points in and of themselves but would suggest the rear of the hotel would be the most suitable location for these, minimising the impact on the green space and residents life conditions. We strongly object to the kiosk proposals and the toilet proposal.

We remain puzzled and disappointed that we have not been properly consulted on this proposal. Mr Hussain notes he thinks the proposals will help both the 'public and the earth' and whilst those are certainly laudable (although perhaps somewhat lofty) ambitions, the proposal is spectacularly underdeveloped and ill supported by proper evidence both in terms of demand for the facilities and the likely impact on both the environment and the local community. We are both very happy to be consulted further.
