I am somewhat concerned by the dramatic increase in glazing proposed by this application, with significant additional full height glazing introduced to both the ground and upper floors to the rear elevation. Whilst I acknowledge that the property is located within a built up area, in which will therefore already be subject to a degree of light spill, the rear elevation backs on to open ground and therefore could create a visible alteration to the night landscape of the area which could impact on dark skies qualities in the area. If possible, I would prefer to see a reduction in the extent of glazing, particularly on the upper floor.

Although not located within the Fylingthorpe Conservation Area, Glendower is located adjacent to the boundary and therefore consideration is given on how the proposed development would affect the setting of the Area, including views in and out. Protection of the setting of the conservation area need not prevent change; indeed change can be positive, for instance where the setting has been compromised by poor development.

Glendower itself is a modern property which in its current state is not of any particular merit and as such I support the applicants desire to improve the appearance of the property. On the whole, the changes to the front elevation will enhance the appearance of the property by creating a 'front' / principal elevation by the inclusion of a porch and front door and unifying the window arrangements which include the removal of the bow window.

While dormers do appear in the wider Conservation Area, they are generally of simple catslide construction. That said, they are not a feature of the immediate area and therefore I am unsure as to how they would look on front elevation of this property and could appear as a discordant feature within the streetscene (particularly when looking west, up Sledgates hill).

With regards to the alterations to the rear roofslope, because of the size and location of the dormers they would significantly change the profile of the roof. While this will be less visible from the west coming down Sledgates hill, because of the gap between Mingo/No.4 Sledgates the change in roof shape would be more evident. I request that the eastern dormer is either omitted from the scheme as a minimum. I would have no objection to the inclusion of two smaller catslide rooflights to the rear.
