I presume from the revised plans that the link extension has been dropped? Is the existing outbuilding therefore to remain unaffected?

On the basis of the amended plan showing an small side extension to the main house, porch and orangery, my only concerns relate to light spill from the glazed orangery, which could create a significant new source of light within this remote and tranquil area thereby impacting on dark skies qualities and nocturnal wildlife.

If the application is approved, please can a bat informative be included with the decision notice.
