I write to strongly object to the proposal for camping pods to be erected opposite Lawns Farm, Ugthorpe. I had previously submitted comments on the original proposal for one pod. It was with great disappointment and disbelief that I saw it was suggested that two pods be positioned in a new site adjacent to the original. I cannot understand how this could be treated as an amended application, nor understand the number of changes that have been made to the plan during the consultation period. The positioning of the pods has been altered 4 times, the latest being as late as January 17<sup>th</sup>. The pods themselves seem to have taken on different names from shepherd's huts, camping pods, and now sheep pens. There was no mention of a septic tank being installed on the original plan for the pod near to the church.

The site proposed is not suitable for 2 pods as is evidenced by the difficulty in finding a position for them. This is a lovely garth, certainly not an orchard, with mature horse chestnut trees (probably 150 years old), one in particular being a fine example, and other species of trees of varying ages which need protection. The agent for the applicants is already talking of pruning metres of spread from one of the trees to enable the huts to be sited. The whole area is full of tree roots, how it would be possible to hand dig trenches deep enough for pipes to be connected to the septic tank is incredible. Specialist equipment would normally be used to place any pipes beneath the tree roots. The applicants have not provided an Arboricultural Impact Assessment from a suitably qualified specialist.

I have read the NYM document relating to the siting of pods. Several criteria are mentioned and are significant to this application. These include – detracting from the character, tranquillity or visual attractiveness of the area – the accommodation is of a high quality design which complements its surroundings – it should be in close proximity to an existing unit which will be used to manage the accommodation and any noise and activity on the site which may occur.

This is a very attractive part of the village and nearby residents, with the support of the Parish Council, have taken pride in maintaining it. At Barrybank we have planted over 100 different trees and shrubs to enhance the lane immediately to the south of the site. We have carefully maintained the existing trees and those planted around 40 years ago as part of a National Park initiative. Local school children, nearly 20 years ago, planted many rare native juniper trees which have been difficult to protect, but are now becoming established. We have never asked for any grants from various schemes but have been pleased to contribute to what is hopefully an area which residents and visitors can appreciate. It is doubtful that people walking along the lane will view the huts with the same feelings. The hedge needed to screen the site is at most one metre high in some places, whilst the pods have a height of 3 metres. There is no screening at the north end of the site.

There have been letters of support for this application, although few for the original, which seems strange. Most have come from people living in the outlying areas of the village and I doubt if some have actually ever visited the proposed site. Most concentrate on the desire to support diversification for the applicants. My original letter states my support for this but it is the actual siting of the pods that I feel is completely inappropriate.

It is interesting that a letter of support has been sent again by the Parochial Church Council, of which the applicant is the Secretary and the only member resident in the village. Point 2 of that letter states in support that the huts/pods will not be visible from the main entrance to the church. This is hardly an endorsement of their appearance - the residents have them in view but they are hidden from the churchgoers.

The applicants reside at another farm in the village – perhaps a suitable site could be found there, near to St. Anne's Church. They also own other large areas of land which could be used. Surely in view of all the factors and difficulties involved in this application it should be refused under the Scheme of Delegation agreed by the National Park Authority. It is extremely likely that there will be many more applications submitted in the locality in the future and surely it would seem sensible that true consultation should take place between all applicants, residents, the Parish Council and Planning Officers in a properly managed way to prevent the discord which has sadly been generated by this application from happening again.
