Hope you are well and apologies for the delay.

We finally attach an amended scheme which has been amended to change the design and reduce areas.

Whilst we have reduced the spaces we have tried to ensure the scheme is practical and worthwhile.

The rear extension is really down to a minimum of 2.45m internally and the Garage is 3m wide internally.

These sizes have created an extension which we believe is still subservient to the Main House and complies with the 'Extensions' Design Guide. In terms of areas:-

- Original House (Ex Garage) 100m²
- Proposals (Ex Garage and covered balcony) 135.7m²
- Increase 35.7%

Externally issues with perceived overlooking have been considered and this element of the scheme reduced to a modest size.

I hope these details are acceptable and look forward to your thoughts in due course. Kind regards Neil
