The proposed development is for 420m of red grade cycle trail which extends the current section 5 to the top of Sievedale. We propose to use soil inversion techniques to use as dug local material to create the trail tread. The trail tread will be 750mm wide with in grade features such as rollers and berms. The trail corridor which is 20m wide will follow a 5% downwards gradient where the micro setting out of the trail will done to find the best line. The trail will be subtle in nature and intended to be fast and flowing rather than feature rich. The proposed new section of trail will join the existing red route approximately 100m along from where the line leaves the forest road. This intersection will be shown on an attached drawing.
