Hi Helen

I've had a look through the details and have no concerns to raise. The PTP looks appropriate for the purpose, and whilst they don't state the capacity or required or the model used, this appears to be a small domestic property for which the 6 PE smallest unit should be plenty adequate. The unit will be sited 40m from the ancient woodland and 70m from the beck so an adequate distance to capture additional solids, and will be an improvement on the current situation of cesspit to drainage field within which there is no treatment.

In assessing the submitted proposals and reaching its recommendation the Local Highway Authority has taken into account the following matters:

The crossing of the highway verge must be constructed in accordance with the approved details and/or Standard Detail number **E9A** and the following requirements.

• Any gates or barriers must be erected a minimum distance of **6 metres** back from the carriageway of the existing highway and must not be able to swing over the existing or proposed highway.

• Provision to prevent surface water from the site/plot discharging onto the existing or proposed highway must be constructed and maintained thereafter to prevent such discharges.

• The final surfacing of any private access within **1 metres** of the public highway must not contain any loose material that is capable of being drawn on to the existing or proposed public highway.
