- 2. Welfare and vehicle parking for site traffic will be on site see map



3. Traffic Management

The Cockmoor Hall car park will not be used for parking and will be available to the public at all times, however all deliveries to site will transit through the car park before entering site. The access route along the bridleway and through the car park will be signed to warn all users. There will be signage on Nettledale Lane either side of the site entrance to inform members of the public. Construction traffic will not enter the site via Snainton. Construction traffic will be directed to approach the site via Brompton by Sawdon along Sawdon Lane.



- 4. Neighbours: The nearest neighbours are 450m from the work site and the site is surrounded by trees so construction noise and dust are not expected to be an issue.
- 5. Drainage: The site is relatively flat and any run off from the construction will be retained within the site within soakaways.

This is a part of the standard wording for that recommended condition. What we require is a basic (preferably joint) photo survey of the route to be used for the additional HGV's, so that we can monitor the condition before and after your works. For the Silpho site it is highly unlikely that anything untoward would be uncovered before or after.

Martin – yes the route from Cockmoor carpark to the Wykeham/North Moor road is also covered and I understand that you do maintain it during the haulage operations and that you repair any damage afterwards. For the route from the Cockmoor site I would possibly expect some verge works might be required to repair over-running due to the nature of the route and the lack of passing places.

If we can agree a date sometime in the near future to have a drive through the route and take any photos I would appreciate it.
