Thank you for your letter regarding our application for planning permission for two Shepherds huts.

We enclose as requested a revised drawing and also a photograph of the site hoping that this may be of help to you.

These huts are not going to be connected to mains drainage and we are intending that waste water and sewerage will be collected in cassette form from Thetford type toilet units and disposed of into our existing 1000 gallon Klargester septic tank which is shown on the amended plan.

We have marked the proposed car parking spaces on the plan and this would be just large enough to allow two cars to turn round and park - entrance would be through the existing gate.

ts would be approx 5.5 meters long x 2.5 meters wide x 2.5 meters high - these huts come in various heights depending on wheel

arrangements but we would endeavour to keen as low as possible

Specification wise they will be fully insulated with curved corrugated roof and either corrugated steel or timber clad exterior. They will most likely be serviced by a 12 volt electrical system, the hut nearest the outbuildings on the east side may have mains electric connection and water connected, If not a water tap will be made available to users.

Until we have your views on what sort of huts would be most acceptable we are keeping an open mind but are in favour of a more traditional look - so it looks like a shepherds hut and not a caravan.
