Thanks for your email – the track is being paid at the Countryside Stewardship (RP4) rate, so we're insisting that the CS requirements are adhered to:

Stone or hardcore to a depth of at least 150mm and compact it; finish the top of the track with a finer material (of 18mm to dust) to a depth of 25 to 50mm and compact it into a convex camber.

I've attached a simple map of the line and length of the proposed new track, marked in red.
