The application is for the construction of a new slightly taller communication mask to improve coverage within this rural area. There are no objections to the proposals on the understanding that no construction traffic be permitted to access the site via Langate between Wrench Green and Great Moor Road, as it is steep single track and does not have any passing places. Although the immediate surrounding routes are un-surfaced they are significantly wider, with less gradient and allow two way traffic.

Good afternoon Mark,

I have reviewed the documents submitted with this application. There are records of several breeding raptors within the plantations, and our records show that there is potential Nightjar habitat onsite. Therefore, I recommend that a condition is included to avoid construction works taking place during the breeding bird season (March-September inclusive). A Construction Environmental Management Plan for Biodiversity (CEMP: Biodiversity) should also be included as a condition of any consent.
