In assessing the submitted proposals and reaching its recommendation the Local Highway Authority (LHA) has taken into account the following matters:

The LHA has taken into consideration the condition of the surface of the access, the provision of the drainage channel, the steepness of the access the gate opening and the amount of traffic that this is likely to attract.

Due to the anticipated small amount of traffic this would expect to attract, the LHA would not require any additional works to improve the surfacing of the access. However, if a future application was to intensify the traffic even further, the applicant should expect the LHA would be recommending changes to the access to bring it up to the current specification.

The LHA are concerned that the existing gate opens outwards over the existing highway. This is not permitted by the LHA and should be altered.
